Practice Direction Sc 1/93

**WRITTEN EXTRACTS OF ARGUMENT: ORDER 11 DIVISION 10 OF RULES OF THE SUPREME COURT**

AS from the 1st day of March, 1993, all parties to a substantive matter instituted (Order 11 Rule 18 refers) under the Rules of the Supreme Court of Justice, are required to comply with the requirements relating to the preparation, filing and service of written extracts of argument and list of authorities and legislation.

It is a requirement under Order 11 Division 10 Rules 18 - 21 of the Rules of the Supreme Court of Justice, that parties to proceedings instituted under the Rules shall prepare for the court a written extract of arguments. The parties are further required by Order 11 Division 11 Rules 22 and 23 to prepare and supply to the Associate to the presiding Judge prior to the hearing of a matter, a list of authorities and legislation to which each party may refer, during a hearing of a matter, for each substantive proceedings (Order 11 Rule 22 refers).

This practice direction requires that, as from the 1st of March, 1993, where a substantive matter and proceedings is instituted under the Rules, all parties shall have written extracts of argument and list of authorities and legislation prepared and supplied to the Court and the Associate respectively, no less than 6 clear working days prior to the commencement of the sittings in which the case has been set down for hearing.

A copy of the written extracts, list of authorities and legislation shall also be served on the opposing party after being prepared and supplied to the Court and Associate respectively, no later than 5 clear working days prior to the hearing of the matter.
