Defence (Period of Service)(Amendment) Regulation 1994

Being

a regulation to amend the Defence (Period of Service) Regulation (Chapter 74)

MADE by the Head of State, acting with, and in accordance with, the advice of the National Executive Council under the *Defence Act* (Chapter 74) to be deemed to have come into operation on 25th December, 1993.

Defence Act (Chapter 74)

RE-APPOINTMENT OF COMMANDER OF THE PAPUA NEW GUINEA DEFENCE FORCE

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(3) of the Constitution and Section 6 of the *Defence Act* (Chapter 74), and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Services Commission, hereby re-appoint Robert Dademo as Commander of PNG Defence Force for a period of three years commencing on and from 24th December, 1993.
