*Professional Engineers Registration Act 1986***NOTIFICATION OF REGISTRATION OF PROFESSIONAL ENGINEERS**

I hereby notify that the engineers specified in the Schedule hereto are entitled to practice as professional engineers in accordance with Part V of the Act and to use the identifying title 'Reg Eng' after their names.
