CONSTITUTION

DETERMINATION OF TEMPORARY RESPONSIBILITIES OF MINISTERS

I, Sir Mekere Morauta, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution, and all other powers me enabling, hereby determine that:—

- (a) the Minister for Correctional Services shall have the responsibilities of the Labour and Employment portfolio; and
- (b) the Prime Minister shall have the responsibilities of the Corporatisation and Privatisation portfolio; and
- (c) the Minister for Public Service shall have the responsibilities of the Provincial and Local-level Governments portfolio; and
- (d) the Minister for Lands and Physical Planning shall have the responsibilities of the Petroleum and Energy portfolio; and
- (e) the Deputy Prime Minister and Minister for Agriculture and Livestock shall have the responsibilities of the Home Affairs portfolio,

with effect from March, 2000 until further notice.

CONSTITUTION

AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, Sir Mekere Morauta, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution, and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 5th January, 2000; and published in *National Gazette* No. G1 on 6th January, 2000—

- (a) in Schedule 5, in Column 1, by deleting the name "Vincent Auali"; and
- (b) in Schedule 6, in Column 1, by deleting the name "Daniel Kapi" and replacing it with the following:—"Andrew Kumbakor"; and
- (c) in Schedule 15, in Column 1, by deleting the name "Sir Mekere Morauta"; and
- (d) in Schedule 18, in Column 1, by deleting the name "Chris Haiveta"; and
- (e) in Schedule 21, in Column 1, by deleting the name "Tommy Tomscoll"; and
- (f) in Schedule 24, in Column 1, by deleting the name "Andrew Kumbakor"; and
- (g) by adding the following new Schedule:—
