APPOINTMENT OF CHAIRMAN AND MEMBERS OF THE COUNCIL OF THE ORDERS OF PAPUA NEW GUINEA

I, Grand Chief Sir Michael Ogio, G.C.L., G.C.M.G., O.B.E., K.St.J., Governor-General, by virtue of the powers conferred by Section 15 of the Constitution of The Orders of Papua New Guinea and Section 3 of the Regulations of The Orders of Papua New Guinea, and all other powers me enabling, acting with, and in accordance with, the advice of the Prime Minister, hereby appoint —

- (a) Sir Frederick Reiher to be Chairman of the Council of The Orders of Papua New Guinea under Section 15 (a) of that Constitution for a term of three years; and
- (b) Ume S. Wainetti, Reverend Charles N. Lapa and Gideon Oli to be members of the Council of The Orders of Papua New Guinea to represent wide interests in the community under Section 15(b) of that Constitution for a term of three years; and
- (c) John Kali, Dominic ToMar and Russell Ikosi to be ex-officio members of the Council of The Orders of Papua New Guinea under Section 15(c) of that Constitution,

with effect on and from the date of signature of this instrument.
