MADE by the Independent Consumer and Competition Commission under Section 21 of the *Prices Regulation Act* (Chapter 320) to amend Public Notice on “Maximum Margins for Wholesale, Retail, and Drum Filling of Petroleum Products” as published in *National Gazette* No. 6 of 12th January, 2011 and to come into operation as of 1st January, 2012.
