- (b) in Schedule 23 (Minister for Health and HIV Aids) —
  - (i) in Column 3 by deleting the following paragraph:  
“(f) Institute of Medical Research”; and
  - (ii) in Column 4 by adding in alphabetical order the following:  
“*Institute of Medical Research Act* (Chapter 166), except Section 24(2) and (5).”.
