Industrial Relations Act (Chapter 174)

APPOINTMENT OF MEMBERS AND ALTERNATE MEMBERS OF THE NATIONAL TRIPARTITE CONSULTATIVE COUNCIL

I, Honourable Benjamin Poponawa, Minister for Labour and Industrial Relations, by virtue of the powers conferred by Sections 9B and 9C of the *Industrial Relations Act* (Chapter 174) and all other powers me enabling, hereby appoint —

- (a) each person specified in Column 1 of Schedule 1 (being a person nominated to represent the Employer Group referred to in Column 3 of Schedule 1) to be Member of the National Tripartite Consultative Council to represent the Employer Groups; and
- (b) each person specified in Column 2 of Schedule 1 (being a person nominated by the Employer Group referred to in Column 3 of Schedule 1) to be the Alternate Member of that Council for the member specified in Column 1 opposite that name; and
- (c) each person specified under Column 1 of Schedule 2 (being a person nominated by the Papua New Guinea Trade Union Congress to represent the Unions referred to in column 3 of Schedule 2) to be a Member of that Council to represent the Union Groups;

Appointment of Members and Alternate members of the National Tripartite Consultative Council - *continued*

- (d) each person specified in Column 2 of Schedule 2 (being a person nominated by the Papua New Guinea Trade Union Congress to represent the Unions referred to in Column 3 of the Schedule 2) to be an Alternate Member of that Council to represent the Union Groups.

For a period of two years commencing on and from the date of publication of this Instrument in the *National Gazette*.
