 - “(r) PNG Water Limited; and
- (ii) Column 4, by inserting "*National Water Supply and Sanitation Act 2016*"; and

- (b) in Schedule 6 (**MINISTER FOR TRANSPORT AND INFRASTRUCTURE**) —
- (i) Column 3, by deleting “(d) National Roads Authority; and
 - (ii) Column 4, by deleting “*National Road Authority Act 2003*”; and
- (c) in Schedule 7 (**MINISTER FOR AGRICULTURE AND LIVESTOCK**) —
- (i) Column 3, by inserting in (I), the words “Institute; and” and
 - (ii) Column 4, by deleting “*National Agriculture Research Institute Act 1996*”; and
- (d) in Schedule 8 (**MINISTER FOR FOREIGN AFFAIRS AND TRADE**), Column 2, by deleting the word “LIVESTOCK” from the title; and
- (e) In Schedule 10 (**MINISTER FOR RELIGION, YOUTH AND COMMUNITY DEVELOPMENT**), Column 3, by inserting “(g) Office for Child and Family Services”; and
- (f) in Schedule 12 (**MINISTER FOR HIGHER EDUCATION, RESEARCH, SCIENCE AND TECHNOLOGY**) —
- (i) Column 3, by —
 - (A) deleting “(a)” and “(b)”; and
 - (B) inserting “Department of Higher Education, Research, Science and Technology”; and
 - (ii) Column 4, by inserting “*National Agriculture Research Institute Act 1996*”; and
- (g) in Schedule 29 (**MINISTER FOR WORKS AND IMPLEMENTATION**) —
- (i) Column 3, by inserting “(e) National Roads Authority.” and
 - (ii) Column 4, by inserting “*National Roads Authority Act 2003*”.
- (h) in Schedule 33 (**MINISTER FOR CIVIL AVIATION**), Column 3, by deleting “(a) Department of Civil Aviation; and” and inserting “(d) Accident Investigation Commission.”.
