REVOCATION OF APPOINTMENT AND APPOINTMENT OF MEMBERS OF SOUTHERN HIGHLANDS PROVINCIAL HEALTH AUTHORITY BOARD

I, **GRAND CHIEF SIR BOB DADAE, GCL., G.C.M.G., K. St. J.**, Governor-General, by virtue of the powers conferred by Section 17(2) of the *Provincial Health Authorities Act 2007*, and all other powers me enabling, acting on advice of the National Executive Council on the nomination of the Minister after consultation with the Governor of Southern Highlands Province, hereby—

- (a) revoke the appointment of **GLORIA RAMI** as a member of the Southern Highlands Provincial Health Authority Board representing Women in the Community as published in *National Gazette* No. G416 of 2018; and
