GAZETTE NOTICE

PART IV – PROVINCIAL PHYSICAL PLANNING BOARDS

I, **Hon. Governor Rufina Peter, MP**, being the member of the Central Provincial Executive Council charged with the responsibility for physical planning in the Province, acting in accordance with Section 20(1), (2), (3) and (4) of the *Physical Planning Act*, hereby declare the membership of the Central Provincial Physical Board as follows:—

In respect of Section 20(1)(a) – the **Provincial Administrator**, as an *ex-officio* member; and

In respect of Section 20(1)(b) – the **National Works Manager**, the officer in charge of the National Works function in the province, as an *ex-officio* member; and

In respect of Section 20(1)(c) – the **Provincial Works Manager**, the officer in charge of Provincial Works function in the province, as an *ex-officio* member; and

In respect of Section 20(1)(d) – the **Provincial Lands Advisor**, the Provincial Lands Advisor, as an *ex-officio* member; and

In the respect of Section 20(1)(e) – **Steven K Wilson**, appointed to represent the private business sector in the province, from nominations received from the Chamber of Commerce; and

(*optional*) also in respect of Section 20(1)(e) – **Warilea Iamo**, appointed as an *alternate Member* to represent the private business sector, from nominations received from the Chamber of Commerce; and

In respect of Section 20(1)(f) – the **Central Provincial Police Commander**, the member appointed by the Minister in accordance with Section 20(1)(f) of the *Physical Planning Act*; and

In respect of Section 20(1)(g) – **Emmanuel Asigau**, appointed to represent professions related to physical planning; and

In respect of Section 20(1)(h) — *appointed* to represent either.

- (i) Sporting bodies or Groups — **Andrew Magaiva**;
- (ii) Churches — **Rev. Roger Joseph**; and
- (iii) Settlements — **Patrick Lauman**

The above—mentioned members, in respect of Sections 20(1)(e), (f), (g) and (h), are appointed for a period of three (3) (up to three years) from the date of this notice.

It is further declared, in accordance with Section 22 and from the above stated membership and after receiving advice from the members (stated), that the Chairman of the Central Provincial Physical Planning Board shall be the **Edward Kila** (Central Provincial Administrator), and the Deputy Chairman shall be **Norman Ray** (Provincial Works Advisor).
