## IMPORT DUTY AND IMPORT GST EXEMPTION

In my capacity as Chairman of the Special Economic Zone Authority Board of Papua New Guinea, and as per the requirements of Part XI (11), Part XII (12), Schedules 2 and 3 of *Special Economic Zone Authority Act, 2019*, I hereby issue this assertion as follows:

1. that consistent with the NEC Decision: 78/2020, the SEZA Board Resolution No. 04, the Project Agreement signed by the Head of State on the 19th of March, 2020, goods listed in Schedule 1, as import shipment by Special Economic Zone User License No. UL004 - Twin Tower Development Limited, developer of Paga Hill Paradise Luxury Apartments within the Paga Hill Tourism Special Economic Zone, are subjected to Special Economic Zone Laws and Regulations, and strictly to be used at the Paga Hill Tourism Special Economic Zone;
2. that consistent with Part XI (11), Part XII (12), the all goods listed in Schedule (1) are subject to Customs Tax Exemption, inclusive of Import Duties, Import GST, and Excise Levies;
3. that consistent with Section (60) & (61) of the *Special Economic Zone Authority Act, 2019*, all goods listed in Schedule (1) are subject to monitoring and compliance by Customs and Special Economic Zone Authority Officials and are to be tagged with Serial Numbers: PHSEZ: xxxxx-date.
