**SOLOMON ISLANDS INDEPENDENCE ORDER 1978
(L.N. No. 43 of 1978)****MEMBERS OF PARLIAMENT (ENTITLEMENTS) COMMISSION
(AMENDMENT) REGULATIONS 2004**

IN exercise of the powers conferred by section 69B(2) of the Constitution, the Members of Parliament (Entitlements) Commission hereby makes the following regulations -

1. These Regulations may be cited as the Members of Parliament (Entitlements) Commission (Amendment) Regulations 2004, and shall be deemed to have come into force on the 1st day of April 2004.

2. Regulation 9(3)(b) of the principal Regulations* is hereby amended by deleting the word "fifty" thereof and substituting therefore the word "seventy-five".

3. Regulation 12(1) of the principal Regulation is hereby amended by deleting the figure "\$15,000" thereof and substituting therefor the figure "\$50,000".

4. Regulation 39 of the principal Regulations is hereby amended by inserting immediately after regulation 39(8) the following new subregulations as follows -

" (9) A transport allowance of \$2,500 per month shall be paid to Ministers and the Leader of Opposition,

(10) Persons holding and garaging Government vehicles shall be paid a fuel allowance of \$300 per month,"

5. Regulation 40(2) of the principal Regulations is hereby amended by deleting the figures "\$1,000" and "\$500" thereof and substituting therefor the figures "\$2,000" and "\$1000" respectively.

6. Part VII of the principal Regulations is hereby amended by inserting immediately after regulation 64 the following new regulation as regulation 64A as follows -

“ 64A. The Members of Parliament shall be entitled to an Insurance Scheme as set out in Appendix D of these Regulations,”

7. Regulation 68(1) of the principal Regulations is hereby amended by deleting the figure “\$300” thereof and substituting therefor the figure “\$800”.

8. Regulation 68(2) of the principal Regulations is hereby amended by deleting the figure “\$600” thereof and substituting therefor the figure “\$800”

9. Appendix A of the principal Regulations is hereby amended by deleting item 1.; BASIC SALARY”, item “2. APPOINTMENT GRANT”, and item “4. CONSTITUENCY ALLOWANCE” thereof and substituting therefor the following respectively -

“ 1. BASIC SALARY
