This proposed amendment to section 8 of the Standing Orders is to include a new subsection 8 (c) to cater for the payment of Sitting Allowances for Members of the Provincial Assembly during meetings.

Proposed Amendment to section 8

Section 8. Sittings

- C. Sitting Allowances of \$100.00 per sitting shall be paid to Provincial Assembly Members when attending Provincial Assembly Meetings. The allowance shall not be paid to Members who do not attend meetings.

The sitting allowance shall be paid from provincial funds in Solomon Islands Dollars.

The entitlements contain in the Terms & Conditions of the Speaker are in no means compatible with the changes in the cost of living over the years.

In view of this I am proposing the following rates for the new entitlements of the Speaker.
