**AN ACT
TO APPROPRIATE MONEYS TO THE SERVICE OF THE
GOVERNMENT**

[11th November, 1991]

BE IT ENACTED by the King and the Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

1. This Act may be cited as The 1991-92 Supplementary Appropriation Act, (No. 2), 1991.
2. There shall be issued from general revenue and other funds of the Kingdom and applied to the service of the year ending the thirtieth day June, One thousand nine hundred and ninety two any sum or sums not exceeding One hundred and ten thousand paangas in addition to the amount approved by the 1991-92 Appropriation Act, 1991 for defraying the charge of the Government of Tonga for such period in the manner expressed in the Schedule to this Act.
3. The Treasurer shall issue and pay such sum or sums of money for the purposes set out in the Schedule not exceeding in the whole the sums respectively in that behalf as the Prime Minister shall be warrant by his hand direct.
4. The moneys granted by this Act are intended for the services in respect of which moneys will become payable within the financial year ending on 30th June, 1992 and any balance thereof unissued at the end of the month of June, 1992 shall lapse and not be available for making payment in any subsequent month.

'OKU TU'UTU'UNI 'e he Tu'i mo e Fale alea 'o Tonga 'i he Fakataha Alea 'o e Pule'anga 'o pehe:

1. 'E ai 'a e Lao ni ko e Lao ki he Fakalahi 'o e Fakahu Atu 'a e Pa'anga 1991-92 ki he Ngaahi Ngaue 'a e Pule'anga (Fika 2) 1991.

2. 'E fakahu atu mei he pa'anga hu mai mo e ngaahi pa'anga kehe 'a e Pule'anga mo ngaue'aki ki he ngaue 'i he ta'u 'oku ngata ia he 'aho tolungofulu 'o Sune, Tahaafe Hivaangeau ma ua 'o tanaki ki he pa'anga ko ia na'e tali 'i he Lao ki he Fakahu Pa'anga ki he Ngaue 'a e Pule'anga 1991-92, 1991 'o 'ikai lahi hake 'i he Pa'anga 'e Taha kilu, taha mano ke totongi'aki 'a e ngaahi ngaue 'o e Pule'anga 'o Tonga 'i he ta'u ko ia 'i he founiga 'oku ha 'i he Tepile 'i lalo ni.

3. Kuo pau 'e fakahu mo totongi atu 'e he Tauhi Pa'anga 'a e Pa'anga pe ngaahi pa'anga koe'uhia ko e ngaahi me'a 'oku fokotu'u atu 'i he Tepile 'o 'ikai lahi hake 'i hono kotoa 'i he ngaahi pa'anga takitaha koe'uhia ko e me'a ko ia 'o hange ko ia 'e fakangofua 'e he Palemia 'i ha'ane tohi nima.

4. 'Oku fakahangahanga 'a e ngaahi pa'anga 'oku fakangofua 'e he lao ni ki he ngaahi ngaue pea 'e totongi atu 'a e ngaahi pa'anga ko ia lolotonga 'o e ta'u Faka-Pa'anga 'o ngata 'i he 'aho 30 'o Sune 1992 pea ka 'i ai ha toe 'o e pa'anga ko ia 'o 'ikai ke fakahu kimu'a 'i he 'osi 'a e mahina ko Sune 1992 kuo pau 'e 'ikai ngaue'aki ia mo ngofua ke fai 'aki ha totongi 'e ha mahina kimui mai.
