**AN ACT
TO APPROPRIATE MONEYS TO THE SERVICE
OF THE GOVERNMENT**

[9th November, 1992.]

BE IT ENACTED by the King and Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

1. This Act may be cited as The 1992-93 Supplementary Development Appropriation Act, (No. 3), 1992.

2. There shall be issued from Development Fund of the Kingdom and applied to the service of the year ending the thirtieth day June, One thousand nine hundred and ninety three any sum or sums not exceeding Three hundred and sixty one thousand, ffive hundred and thirty one pa'anga in addition to the amounts appropriated in the Development Appropriation Act 1992-93 ffor defraying the charge of the Government of Tonga for such period in the manner expressed in the Schedule to this Act.

3. The Treasurer shall issue and pay such sum or sums of money for the purposes set out in the Schedule not exceeding in the whole the sums respectively in that behalf as the Prime Minister shall warrant under his hand direct.

4. The moneys granted by this Act are intended for the services in respect of which moneys will become payable within the financial year ending on 30th June, 1993 and any balance thereof unissued at the end of the month of June, 1993 shall lapse and not be available for making payment in any subsequent month.
