'I HONO NGAUE'AKI 'o e ngaahi mafai 'oku foaki 'i he kupu 19(1) 'o e Lao ki he Pule'i 'o e Toutai 2002, 'oku tu'utu'uni ai heni 'e he Minista 'oku ne tokanga'i 'a e toutai, 'i he lotu ki ai 'a e Kapineti, ko e fanongonongo na'e kasete'i 'i he 'aho 26 'o Me 2013 'o ta'ofi ai hono to'o, ngaohi mo hu ki tu'apule'anga 'a e mokohunu mei he ngaahi 'otumotu 'o Tongatapu, Ha'apai mo Vava'u ki he ngaahi taumu'a fakakomesiale mo hono hu atu ki tu'apule'anga, ('a ia ne 'uluaki toloi fakataimi hono ngaue'aki 'i he Kasete Fanongonongo 9 'o e 2013 na'e kasete'i 'i he 'aho 7 'o 'Aokosi 2013) kuopau ke to e toloi fakakonga fakataimi hono ngaue'aki ki he 'aho 31 'o 'Okatopa 2013, ka ki he ngaahi taumu'a ngaohi mo hu ki tu'apule'anga pe 'o e mokohunu:

PEA ke 'oua 'e 'i ai ha veiveiua –

- (a) 'oku fakapapau'i heni ko hono to'o 'o e mokohunu 'oku tapui ia hili 'a e 'aho 30 'o Sepitema 2013; pea

## NOTICE

### FISHERIES MANAGEMENT ACT 2002

(Section 19(1))

IN EXERCISE of the powers conferred by section 19(1) of the Fisheries Management Act 2002, the Minister responsible for fisheries, with the consent of Cabinet, hereby orders that the notice that was gazetted on 26 May 2013 imposing a moratorium on the harvesting, processing and export of sea cucumber from the island groups of Tongatapu, Ha'apai and Vava'u for commercial and export purposes, (as first suspended by Gazette Notice 9 of 2013 gazetted on 7 August 2013) shall be further partially suspended until 31 October 2013, but only for the purpose of processing and export of sea cucumber:

AND for the avoidance of doubt –

- (a) it is confirmed that the harvesting of sea cucumber after 30 September 2013 is prohibited; and
- (b) the said notice imposing the moratorium will come into force again from 1 April 2014 until further notice by the Minister.
