**EXCISE TAX ACT 2007**

**(Section 3(1)(c))**

**ORDER**

**IN EXERCISE** of the powers conferred by section 3(1)(c) of the Excise Tax Act 2007, the Minister responsible for revenue and customs, with the approval of Cabinet, makes the following Order –

(1) That the imports of heavy machineries and its parts, classified under the following tariff headings and codes shall be exempted from excise tax -

- (a) Tariff Code 4011.20.00;
- (b) Tariff Code 4011.80.00;
- (c) Tariff Heading 8705;
- (d) Tariff Heading 8706;
- (e) Tariff Heading 8707;
- (f) Tariff Heading 8708.

(2) That this Order shall come into force on the date of gazettal.
