**RELEASE DECISIONS**

**Hearing Date:** 5<sup>th</sup> July 2019

**Location:** Port Vila

**Detainee Name:** Alex Timor

**Decision:** Sentenced to 5 years imprisonment for sexual intercourse without consent and threats to kill. He has gone through the required rehabilitation programs. He was honest to inform that he was disciplined once by the manager although the report records no misconduct. We are satisfied from his report that he is sufficiently rehabilitated and that he poses no further risk to the community. His application is therefore approved for parole on the special conditions proposed in his report. He is to remain on parole until 19/12/2020.

**Detainee Name:** Timothy Boita

**Decision:** Charged and sentenced to 4 years 7 months imprisonment for Arson since 31 October 2016. Currently serving at the low risk unit. Having gone through the required rehabilitation programs with no recorded misconducts. We are satisfied he does not pose any risk to the community. We therefore approves his release on parole to remain on special conditions as proposed until his sentence end date on 31/05/2021.

**Detainee Name:** Samuel Sam

**Decision:** Charged and Sentenced to 5 years imprisonment for 3 charges of S/I without consent, A/I without consent and S/I with child under care and protection. He has undertake the required and relevant rehabilitation programs. He has no recorded misconduct whilst serving at the low risk unit. His chief attended the hearing in person and guide support for his release. We are satisfied he poses no further risk to the community. We therefore approve his release on parole to remain until 06/01/2022.

**Detainee Name:** Presley Kalfau

**Decision:** Charged and Sentenced to 3 years 8 months for U/S/I, trespass damage to property and abusive and threatening language since 23 august 2017. He is undertaken the relevant rehabilitation programs. There is no recorded misconduct on his part. His father attended the hearing and spoke in support of his son's release on parole. His chief also supports his release. We are satisfied he does not pose any risk to the community. We therefore approve his release on parole to remain on conditions until 23/04/2021.

He has made an advanced application.

We approve his release on parole to remain until 13/06/2020.

He is only eligible for parole after 23 July 2019. He has taken relevant, rehabilitation programs. He has no recorded misconduct. We are satisfied he is ready for parole with no risk to the community. We approve his release on parole on special conditions until 8 march 2021.

**Detainee Name:** Marcel Tabigerian

**Decision:** Charged and Sentenced to 7 years imprisonment for S/I without consent since 11 december 2015. Currently serving at the low risk unit. Has gone through relevant rehabilitation programs. No adverse reports or misconduct. We are satisfied he poses no risk to the community. We approve his release on parole to remain on special conditions until 11/06/2022.

We approve his release on parole on special conditions to remain until 7/06/2021.
