Followem pablik notis ia Chief Henry Manlaewia mo Chief Maripongi & Famili blong Tanmiala oli rejisterem olketa documents blong olketa blong contestem Orijinol klemant

Ino gat trial long kes ia kasem 9 November 2009 taem we Kot hemi holem first pre-trial conference long 9 o'clock long morning long Magistrates kot long Vila. Mo adjournem kes igo long next day 10 November 2009 long 9 o'clock blong hearem olketa parties.

### **NEMS mo BAONDRIS BLONG LAND:**

Kraon ia istap long North Efate long village blong Paunagisu.

Istart long ARUSE long man made well long sea kost iran inland kasem wan Laken Napanga; then southern direction igo long area blong Maulapa kasem Laken Namele then tekem direction toward Laken Nakavika; then tekem direction towards Laken Nakoka long area blong Maulapa yet. Long ples ia lukluk igo long South West long Tavan' Nasusun Natara olsem custom campus, then go long Laken Natalie bakeken long area blong Davea Loa. Then ikrossem main road mo go kasem MAULAPA;

Kot hemi explainem procedure we bambae hemi followem blong harem kes ia. Bambae each klemant ipresentem **statement blong kes** blong hem, then hemi produsum olketa evidences through long olketa **witnesses**. Bambae olketa klemants oli testem olketa evidences/information through long:

- Examination in Chief,
- Cross examination mo
- re-examination.

### **LAWS:**

#### **1980, CONSTITUTION OF THE REPUBLIK OF VANUATU:**

Article 73. All land in the repablik of Vanuatu belongs to the **indigenous kastom owners and their descendants**.



*Central element mo land policy long Vanuatu taem hemi kasem independence long 1980, hemi blong returnem every land igo back long Indjenous kastom onas. Every pre-independence freeholds mo leaseholds oli stop. Freeholders we oli registered olsem "alienators" oli entaetel blong kasem wan lease long commercial or residential rates or blong receivim wan compensation long improvements we oli been makem long land in kwesten.*

**Aritce 74. The rules of kastom shall form the basis of ownership and use of land in the Repablik of Vanuatu.**

*Blong findem kastom onas, Kot of law hemi must usum kastom law mo Rules blong usum land long Vanuatu.*

**Article 75. Only indigenous citizens of the Repablik of Vanuatu who have acquired their land in accordance with a recognised system of land tenure shall have perpetual ownership of their land.**

*Olketa Ni Vanuatu we kastom onas blong kraon ia oli givim raet over long kraon ia long olketa nomo oli gat raet blong holem free taetel.*

#### **Aelan Kot Act Cap 167**

#### **Aelan Kot civil procedure Rules**

*Role blong Aelan Kot under section 8 blong Aelan Kot Act hemi blong applaem kastomeri law blong erea we disputed land hemi located long hem. Decisen blong hem, hemi no must conflict wetem any written law. Mo too hemi no must stand againstem spirit blong justice, reality mo good order. Kot hemi gat power too blong mekem orders ia:*

- a) Money olsem compensation;
- b) Restitution blong property
- c) Use mo occupation blong land igo long any party long dispute,
- d) Prohibitim or restraining use blong land by any long olketa disputing parties

#### **Kastom of Efate-particularly North of Efate.**

Long Kastom blong Efate, raet blong onem wan land hemi pass followem bladlaen blong man or patrilineal mo olketa exceptions blong hem we Kot hemi tok about long case blong Eleo-Eurakot (Land case 5 of 1993 we kot ia hemi disaed long March 2009).

Long erea we dispute ia istap long hemi oli followem bladlaen. Dispute ia hemi involvem olketa following aspects blong onaship blong land long kastom blong Efate, olsem :

- A. Kastomeri Land onaship hem based generally long patrilineal system;
- B. Exception long rule blong patrilineal. Woman isave tekem right sapos inomo gat bloodline blong man istap;

#### **KASTOMERI LAND TENURE:**

- a) Bigfalla Chief hemi controlem, managem mo protectem olketa interest over lands blong olketa people we oli stap under long jurisdiksen blong hem.



- b) Head blong Tribe: Hemi minim olketa assistants blong big Chief we Chief hemi givim specific kastom duty long olketa. Olsem warias, Munuwei...etc. Olketa ia oli head blong tribe we oli kamaot long side blong ol "man" long famli bladlaen blong big Chief or yumi save talem se olketa "brothers" blong hem.
- c) Head blong Klan: hemi minim olketa Chiefs blong Naflak. Olketa oli head blong Chief blong Naflak we oli kamaot long saed blong olketa uncle blong Chief. Yumi save talem se olketa "tawian" blong hem.

## **STANDARD OF PROVE:**

Standard of prove hemi long Probability.

Hemi duty blong Kot ia blong showem se hemi followem stret Constitution blong Vanuatu, 1980. Bambae hemi must applaem kastom olsem basis blong onaship blong kastomeri land raets, however desisen blong hem bambae hemi no must be inconsistent (igo against) wetem Article 73 mo 74 we hemi talk about onaship mo Perpetual onaship blong land.

## **FACTS:**

### **LAND VISITATION:**

Kot itekem appearance, everyone istap mo oli depart long kot long 8.30 am, long 24 November 2009 igo long kraon. Plante people oli accompany Kot, but olketa parties mo spokesperson blong olketa nomo oli allowed blong go luk any particular kastom sites. Visitation hemi tekem wan dei nomo.

Kot iarrive long area in dispute long 9.45 am istart long:

- spring water long head blong Nambakura down long solwota long Emua,
- igo long white wood long main road;
- igo inland north long Namalaus tree;
- igo long east long Vatu Varao;
- Stret back long solwota long Vatu Varao, then everyone iproceed long main boundary olsem:
- Malosa (Tabu water)
- Moro ni Natamate, Vare sumansaipiri,
- Noai Aruse man dug well (wan bigfalla oldfalla Oak tri (oli just burnem)) ;
- Noai Aruse Naturel walter (about 200 m from the well)
- Original kleman ishowem 5 different sites nakamal or Varea.




**HISTRI:**

Chief **MANAVILALU**, Chief **LAKELEOWIA** mo chief **MANLAEWIA**, trifalla last man blong MALASALIU.

Chief **MANAVILALU** hemi supreme custom chief blong namarakiana blong MALASALIU. Hemi no kat pikinini be hemi kat wan sista nomo we hemi LEITALIE, tufala iblong bikfala nakamal WORAMALA.

Chief **LAKELEOWIA** hemi brother blong Chief **MANLAEWIA** tufala iblong Varea NATALIE SAIPIRI. Chief Manlaewia imarretem Leimaire be tufalla ino kat pikinini. Chief Lakeleowia imarretem Leitalie sista blong Chief Manavilalu mo tufalla igat 3 pikinini: TOARA SARIAMATA, TALIETA MO TOARA LESSA.

Taem Good News ikam long Efate long late 1800s, olketa man long inland olsem **SAVAKI**, **TANOMIALA**, **SUASU**, **TARIANGI**, **ROMOSO**, **LUMA**, **MALAWOTA** mo **RAVENGA** oli been kam down long Malasaliu mo go settle long Kakula. Taem oli kam back long Efate, instead blong oli go back long olfala villages blong MALASA LAND 1/90



olketa long bush, oli stap nomo long **PAUNANGISU**; mekem tudei igat instability long land blong olketa fore fathers blong olketa.

Insaed long Malasaliu igat 5 different Varea:

1. Varea <b>WARUA WORAMALA</b>	<b>Chief MANAVILALU</b> (Paramount chief) <b>Chief MARVATUTIPUA</b>

3. Varea <b>PANGTAMATE</b>	<b>Chief MANLAERANA</b>
4. Varea <b>SEPATI</b>	<b>Chief PAKOA MAAU</b>
5. Varea <b>SILIMANU</b>	<b>Chief TOKAIMAKAU</b>

**Meaning blong olketa chiefly names ia:**

**Chief Manavilalu:** imean kaekae iwaste. Taem hemi mekem kakae or naleoana (feast) kakae iolsem toti nomo (plentyfull, more than enough);

**Chief Marvatutipua** hemi Mataisau or namatapua (builder) blong chief we irresponsible long varea Woramala blong Chief Manavilalu.

**Chief Lakeleowia** hemi responsible long sierau mo aurea olsem sharem olketa something long village blong Malasaliu mo organisem old danis mo naleoana.

**Chief Manlaewia** hemi blong passem any news blong chief Manavilalu;

**Chief Pakoa-Maau** mo **Chief Tokaimakau** tufalla Maau blong Chief Manavilalu. nakamal blong tufalla chiefs ia istap long end blong boundaries blong Malasaliu.

Chief Manavilalu hemi gat kustom connection wetem bigfalla chief blong Pele. Taem big chief iwandem kakai human flesh, Manavilalu iprovidem long hem mo putum long Nagisu Ni Piriwosa (Paunangisu Point) blong chief ia ikam pikimup. Olsem paramount Chief Manavilalu isave performem kustom ordination blong chief Tagarasilasa blong Sake Tassiriki blong Pele we hemi too iwan paramount chief.


Famili tri blong MANAVILALU MATUA:

Sister blong MANAVILALU imarretem LAKELEOWIA, tufalla igat 3 pikinini: TOARASARIAMTA, TALIETA mo TOARALESSA.

- Current chief LAKELEOWIA mo MANLAEWIA tufalla ikamaot long TOARASARIAMATA;
- Current chief MANAVILALU, MANLAERANA, MANLAESINU mo PETER MARIPOPONGI oli kamaot long TALIETA; mo
- MARVATUTIPUA ikamaot long TOARALESSA.



## CHIEF MANAVILALAU MATUA igat 2 pikinini



Kot ihearem evidences blong olketa witnesses blong hem:

**WITNESS 1 TITUS TARIPU** spokesperson blong Original klemant, sworn.

Hemi born long 1961 long Vila, papa blong hem Willie Taripu blong Nguna, hemi grew up long Paunangisu. Mama blong hem Nelly blong Paunangisu. Hemi related long Manavilalu through long mama blong hem Nelly. Nelly hemi daughter blong Kaloris, Kaloris hemi son blong Toumanu, girl blong Toarasariamata.

Long toktok blong hem Chief Lakeleowia mo Chief Manlaewia tufalla ibrothers; tufalla iblong SUMAN SAIPIRI. Mo Chief Manavilalu now hemi paramount chief blong Malasaliu.

Solomon himself we ibin holem title blong Manlaewia bifo Henry, hemi blong Tariang. Hemi born before mama blong hem imaret.

Blong provum klem blong original klemant, witness iclaim se long kastom one Namarakian imust gat 1 Mwalala nomo; be igat evidence long olketa report blong ol Missionaries se igat 2 Mwalala long area ia: Malasa mo Tamiala. So imust igat 2 paramount chiefs.

Furthermore Insaed long Malasaliu igat 5 Vareas:

- Woramala,
- Saipiri,
- Pangtamate,
- Silimanu (sikia) mo
- Sepati

Taem Chief Henry Manlaewia hemi ordained, group blong Chief Manavilalu mo Lakeleowia (orijinal klemant) now itakem new chief Manlaewia iwalk over long boundary blong title ia.

Hemi save se Manlaewia hemi brother blong Lakeleowia. But Chief Thompson Tagarisi ibin ordainem Silas long name ia Manavilalu, taem offalla Silas idead long Emua.

Main evidence blong witness ia hemi blong talem long kot se:

1. **Manavilalu** hemi big chief. **Manlaewia** hemi smol chief blong tekem news blong chief Manavilalu igo outside. Sapos Manavilalu hemi Paramount chief mo hemi ownem land, mo Manlaewia hemi chief blong passem news blong Chief Manavilalu, kastom bae idictate se Manavilalu now imust ordainem Manlaewia. Mo showem boundary blong chiefly title ia long hem. Hemia ino happen.
2. Chief Raymond Marongoe now ishowem boundary long Manlaewia. Kot iluk chief Raymond Marongoe mo appreciatem se hemi older than Henry Manlaewia mo hemi lukaotem Emua we isharem common boundary wetem Malasa long taem finish. Furthermore long famili tri blong original klemant, Chief Raymond Marongoe hemi great grand son blong Talieta; So sapos Manlaewia hemi ordained blong Luk after Malasa land, then hemi probable se Bounadri blong Malasa hemi Siloa blong clan blong NAWI mo bambae hemi stret blong great grand son blong Talieta ishowem boundaries blong jurisdiction blong klan Nawi.
3. Long wan Namarakian imust gat wan Mwalala nomo. Mwalala hemi just wan custom dancing ground. Olgeta kastom advisors mo evidences long Kot ishowem se olketa smol/assistant chiefs oli save gat own Mwalala blong olketa too, apart from that of the High chief. So hemi depend nomo long wan wan chief.
4. Papa blong witness ifirst born son blong Toumanu. Logically papa blong witness ishould inehritem title blong either Lakeleowia or Manlaewia, but title igo long pikinini blong Leisau (girl) we hemi second born pikinini blong Toumanu.
5. Solomon ino should ordained "Manlaewia" from hem (Solomon) himself iblong Tariang. Hemi born before mama blong hem imaret. Hemi not so clear how Solomon ibin holem title Manlaewia; from Solomon imarretem Leisau; long famili tri blong original klemant. Does witness hemi wandem givim contradictori evidence long kot ia? Sapos Solomon hemi no entitle blong holem title Manlaewia from hemi *illegitimate child*; then title ia ishould remain wetem husband blong mama blong Solomon. But witness ino clearem point ia.... But one thing iclear se Henry hemi pikinini girl blong Ann Cyrel, Naflac Nawi blong Leisau we ipass down from Toumau. Furthermore Cyrel (papa blong Henry) hemi pikinini blong Dorothy we imarretem Kalmara.  
Kalmara hemi only male blood long line blong Chief Manavilalu mo Lakeleowia. Though hemi no stret pikinini blong Kalmara; be Kalmara iconsiderem hem olsem stret pikinini blong hem from hemi wan pastor.

Step brother blong Cyrel hemi Keith we ibornem Solomon mo Kalmaire. Keith istret pikinini blong Kalmara. Solomon ia iordained Marvatutipua. Iluk olsem marret blong Cyrel wetem Ann hemi followem kastom blong holem title blong hem olsem spokesperson or man blong passem news (olsem Orijinal klemant italem); But, blong Marvatutipua.

**WITNESS 2 KALMAIRE KALMARA, sworn & states:**

MALASA LAND 1/90



Hemi gat 38 years, papa or bubu blong hem hemi late Pastor Kalmara. Tom Kalmara hemi ded long 1989. Before hemi ded hemi givim title Marvatutipua long Solomon bigfalla brother blong witness ia. Mama blong witness ia Dora mo mama blong Dora hemi Nelly. Tom Kalmara hemi boy blong Toara Lessa. Toara Lessa hemi brother blong Toarasariamata mo Talieta. Papa blong olketa hemi Vakalorisu. Toaralessa imove igo long Kakula mo ded mo oli berem hem there. Hemi confirm se Lakeleowia hemi smol chief blong Malasa.

Hemi no clear from wanem party istap talem se Manavilalu hemi paramount chief mo Lakeleowia hemi smol chief from taem yumi followem family tree iluk olsem current Manavilalu hemi kamaot long Talieta but followem history blong Lakeleowia hemi kamaot long Toarasariamata we hemi first born brother blong Talieta mo Toara Lessa.

Between the two, long saed blong land taem ino gat bloodline blong man, girl blong Toarasariamata now bambae itekem title ia. But sapos oli followem Naflac bambae Manavilalu hemi tekem. Long ples ia Manavilalu hemi naflac Nawi go kasem Silas (current Manavilalu); but Kot ino gat enough evidence long background blong mama blong Winnie we hemi mama blong Ernest, blong save followem gud line blong tufalla brother chieves ia. Bakeken bambae Henry hemi stap long better position blong stand high sapos hemi followem naflac from hemi son blong Anne (Naflac Nawi).

Witness ia hemi seems blong talem long Kot se igat 3 chiefs long area ia: Manlaesinu long Emua, Manavilalu long paunangisu mo Marvatutipua long Lonkarae. But yet trifalla chieves ia oli kamaot long same famili tri blong tufala original Chieves Manavilalu mo Lakeleowia. Though male bloodline istap wetem Solomon Keith Kalmara we hemi ordained Marvatutipua, oli continu blong putum hem aside long dispute blong land.

Kastom hemi required se Custom ownership over land hemi pass through bloodline line blong "man". So Kot imust luk se tufalla titles (Manavilalu mo Lakeleowia) oli must flow through long bloodline blong "man".

Tudei Solomon mo Kalmaire nomo tufalla istret bloodline male blong Toara Lessa from Toarasariamata ileavim behind 1 girl nomo (Toumanu) mo sister blong tufalla Talieta. Mo Solomon iordained chief Marvatutipua.

*Question se sapos tufalla nomo istap why tufalla ino orijinetem klem ia? moreover from wanem tufalla ino playem main role insaed long klem blong ground?*

Maybe in the past understanding long area ia, se land in dispute hemi blong klan blong Yam or Nawi mo chief blong klan now hemi decide. Mekem se olketa chief we oli kamaot long saed blong woman nomo oli save olketa boundaries mo history blong olketa over long land ia.

Witness confirm se Lonkarae iblong Phippe mo Flora. Oli givim long tufalla girls ia from long taem ia igat 1 boy nomo long famili.

Long famili tri we oli produsum igat 3 Phippe.

*Ino clear se witness hemi stap talk about which Phippe?*

Sapos witness immeanim Phippe we hemi girl blong Leinase then, hem mo Flora tufalla ifollowem naflac blong Talieta from tufalla igat 2 brothers ( Kalnagis mo Tom) be ino 1 olsem witness italem. Witness hemi stap talk about Phippe we hemi sister blong Kalmara. Phippe mo Lissy tufalla igat wan brother nomo (Tom Kalmara).

Surprisingly witness hemi stap talem long Kot se hemi obtainem wan restraining order, but ino clear se againstem who? But information we hemi passem long kot se bubu blong hem igivim land long tufalla (Phippe mo Flora); istap indicatem long Kot ia se Ps Kalmara now hemi owner blong ground ia we Phippe mo Flora istap ownem, how now Manavilalu we hemi bubu boy blong Flora istap talem se hemi Paramount chief? mo hemi Kastom owner blong land Malasa? Bakeken evidence ia ishowem se igat great confusion between ownership blong land mo title blong Chief long eria ia. But general understanding is that Land hemi followem bloodline blong man.

Witness ia continue se in the past, oli sharem land blong olketa man oli occupaem nomo, olsem Lonkarae mo Laulapa we igo long control blong Manlaesinu blong Emua kasem tudei yet. Chief Peter Maripopongi hemi blong Tannmala, oli ordainem hem long Paunangisu. (page 114 – 200 diary blong Peter Milne long Nguna).

Information olsem ileadim Kot blong belief se igat confusion too long boundary blong Emua mo Paunangisu.

Chieves blong Paunangisu mo Emua tufalla irelated mo tufalla ikamaot long famili line blong Torasariamata, Talieta mo Taora Lessa. Hemi probable se Missionaries McDonald mo Milne tufalla iplacem wan kind "Christian" boundary. Bambae Kot isettem common boundary long decision blong hem.

### **WITNESS 3 CHIEF RAYMOND MARONGOE sworn & states:**

Papa blong hem Morris mo hemi small chief long Malwaka. Papa blong hem ided long 1943. Mama blong hem Flora hemi blong Pele. Mama blong mama blong hem Leintass. Hemi been ordained long 1959 olsem chief Manlaesinu blong Emua. Former Chief hemi ded long 1967. Mo Chief Marongoe istart rulem Emua (Laulapa kasem Laonkarae) long 1967. Ino been gat bloodline long time ia so oli choosum hem blong hemi holem title blong Manlaesinu. Hemi save se boundary igo kasem nambagura tree long spring water long Emua.

Hemi walk over boundary blong Malasaliu wetem Peter Maripopongi we hemi marretem PIELAU, sista blong Witness ia. Peter Maripopongi hemi bigfalla chief blong Tanomiala; same chief we 2<sup>nd</sup> mo 3<sup>rd</sup> claimants oli klem under. Mo long 1988 oli walk over long boundary bakeken wetem Johnson Kalfau papa blong 3<sup>rd</sup> Kaonta Kleman mo other people. Witness ia hemi Atavi blong Chief Maripopongi.

Long taem ia oli identifaem boundary blong Malasaliu mo Tanomial. Long taem ia ino been gat dispute. Tanomiala mo Malasaliu tufalla different lands. Long kastom 1 namarakian igat 1 mwalala nomo.

Hemi confirm se Malasaliu hemi wan flat land, ino gat stone so oli stap markem boundary long ol trees; time one tree long boundary ided, oli plantem narawan blong replacem. Hemi talem se since hemi rulem Emua hemi save good everyone we oli live long area ia. Famili Kalomele oli kamaot long Emau. Famili blong hem igat Toara Kalorip, Daniel mo Apu blong Spokesman. Kalomele imarret igo long Tanomiala. Vakalorisu iblong Tanomiala, hemi marrietem Talieta blong Malasaliu.

Chief Marongoe iconfirm se hem iordainem Henry Manlaewia. Mo talem long hem se hemi should helpem chief Manavilalu blong showem stret boundary long hem.

Hemia imply se Manlaweia now bambae idecide long boundaries blong chiefly title blong Chief Manavilalu.

Hemia hemi wan oldfala chief, mo hemi Justice blong island kot, hemi sitdaon long plante land case. Kot ia ibelievim wanem hemi talem se land hemi wan flat land mo oli usum ol tris blong markem boundaries. Hemi confirm too se hemi iwalkbaot long boundri blong Malasa 3 times:

1. wetem Peter Maripopongi
2. wetem Johnson Kalfau, mo
3. wetem Manlaewia.

Hemi ordainem Henry Manlaewia.





Among olketa people ia igat some people blong Tongariki too we oli marretem olketa woman Malatuel village antap long Undine Bay; olketa everyone igo long Kakula taem Missy hemi move igo there.

Long taem ia KALSURAI we hemi great grand father blong klement ia hemi marretem LEINTASI, wan women Tarianga village.

Brother blong Kalsurai, Charlie Luisui ibeen go tij long Pele mo marretem sista blong Chief Maserei be tufalla ino gat pikinini. During long migration igo long Kakula island long 1884, Charlie Luisui too imove igo wetem waef blong hem mo ol famili blong waef blong hem. Olketa everyone oli go settle wan place nomo wetem famili blong chief MANLAEWIA long SUMANI WORAKAVIKA long Kakula Island. Oli gat wan passage blong olketa too we oli kolem “ELAU NI MALASA”. Oli stap kam back long Malasa blong collectem kakae mo water.

Long 1890 Charley Luisui we oli stap calleem hem too Charley Soso hemi salem wan pis graon long Malasa igo long Henry Taylor (wan trader). Long 1906 hemi



Henry Cyrel Manlaewia iconfirm full statement blong claim mo olgeta kastom stori, famili tri mo ol exhibits. Hemi prodiusim 2 famili trees— Chief Manlaewia mo Chief Marvatutipua blong showem se mama blong hem Ann ikamaot long chief Solomon Manlaewia mo papa blong hem, hemi pikinini boy blong wan white man Minto. Minto iabandonem hem wetem mama blong hem Dorothy mo Ps. Kalmara imarretem mama blong hem. Pastor Kalmara hemi pikinini boy blong Toaralessa. Toaralessa hemi pikinini boy blong chief Marvatutipua we istap long famili tree blong original kleman.







Tufalla ireturned long Kakula long saling ship we Dick Vakau Tinabua blong Tongoa island (Papa blong Stephen Kaloris-Original claimant) hemi work long hem. Olketa famili blong Namele oli givim ground we olketa famili ia oli claimem tudei igo long Stephen Kalorisu blong pem out pasis blong tufala.

Chief Maripongi now long taem ia hemi stap olsem hed Chief blong boundary mo antanit long hem igat ol chiefs ia:

- Chief **Matarimau** – hemi lukaotem Morun Natamate, Lanmegeve mo Napara. Nakamal blong hem Lanmegeve;
- Chief **Manapanga** hemi lukaotem ground we istap long area blong **Vatu Farau**; Nakamal blong hem istap long **Vatu Farau**;
- Chief **Namalikokona** hemi lukaotem area ia we nem blong hem Laken Natalietangi we sem taem hemi Nakamal blong hem;
- Chief **Masemanti** hemi lukaotem area we istap long **Sumansaipiri** mo tu Nakamal blong hem **Sumansaipiri**;
- Chief **Nansanga** hemi lukaotem erea blong **Moru ni Natamate** kasem Matanakai mo igo antap kasem **Senakel**. Nakamal blong hem **Moru ni Natamate**;
- Chief **Matoatau** chief ia hemi lukaotem erea blong Nasu insaed long tapu ples blong Tanomiala;
- Chief **Masemansarape** hemi lukaotem area we ikaveremap Lanagau kasem Marius; nakamal blong hem Lanagau-hemia klosap long ples we oli stap kilim ol man mo hangem olgeta blong istap mo oli sting koko oli nomo smel. Name blong hem Laken Natofea loa;
- Chief **Manavilalu** hemi stap tekemaot toti blong chief Maripongi mo istap mekem parcel long ol ded body we oli **smokem** mo sendem long Chief **Matangarasi** blong Pele Island. Hemi putum long point blong Paunangisu we oli kolem Nangisu ni Piriwosa. Ples we oli smokem ol bodies ia long hem oli kolem Laken Totomani mo nem ia still in use kasem tudei. Nakamal blong hem oli kolem Tamatelaapa;
- Chief **Manlaewia** hemi lukaotem area we hemi stat long varea ni sui kasem sikia. Nakamal blong hem istap long sikia;
- Chief **Maripokai** hemi lukaotem area we istap long **Vatu Wenu** kasem Matanawora. Nakamal blong hem istap long **Vatu Wenu**;
- Chief **Marmasoe** hemi lukaotem area blong Monmono kasem Lukurara. Nakamal blong hem istap long Lukurara.

## Part 2: Impact blong arrival blong Missionaries wetem gospel:

Start long 1883 olketa people around olsem Ravenga, Luma, Romoso, Tareang, Malawota, Suasu, Neava mo Savaki oli move igo closap long ol missionaries. Oli



stap long Launwora we tudei Manua Primary school istap long hem. Long ples ia Missi idividem olketa long 2 krup. Krup 1 oli ko down long Siviri mo oli stap wetem Daniel McDonald. Krup 2 istap long Launwora wetem Peter Milne. Taem ia ol chritians oli mixed nomo; oli no folowem village or island. Long taem too oli teach mo learnem language blong Nguna nomo. Mekem se plante native oli lusum language blong olketa.

After sometime, oli facem mosquitoes bites mo backslidings so Missy itekem olketa man igo long Kakula island blong isolatem olketa from cultural atmosphere we istap disturbem olketamekem se olketa natives oli tempted blong go back long kastom style blong olketa mo from mosquitoes too.

After 27 years long Kakula olketa people oli change mo pis mo lav hemi mekem olketa oli considerem others olsem Christian brothers, olketa man Efate igivim land long olketa we oli no gat ground blong oli live mo kakae long hem. Olketa ground ia some long olketa oli salem mo others oli holem kasem tudei. Annexure VMS 4 ( Deed of transfer of lands to Mission on 24 June 1884) hemi evidence se long taem ia Chief Maripong we oli recordem olsem "Chief MARIKI POG" MO Chief Mansemanserape we oli recordem olsem MASEI MANSARAB tufalla isignem transfer note. Oli recordem tufalla native se tufalla blong MALISA. Tufalla chiefs ia tufala iblong Tanmiala.

### **Establishement blong Paunangisu**

Between year 1911 mo 1912 olketa man oli out long Kakula mo go back long main land mo buildim olketa houses blong olketa long surrounding area blong Malosa we tudei yumi calle Paunangisu. Paunangisu hemi stap insaed long land we deed blong transfer blong 1882 hemi givim raet long Missionary blong build long hem.

After plante year olketa early Christian converts ia oli think se oli kastom owna blong ground. But hemia name blong olketa famili we oli kam mo settle long Paunangisu mo stap kasem tudei:

- Lui Surassa blong Ravenga-papa blong Manuwia, Wallace mo Esron;
- Narasliliu blong Luma, mama blong Kaltonga mo Kalson;
- Kalsuran blong Romoso, papa blong Solomon Manlaewia;
- Samisuamanu blong Tareang, papa blong Melta mo Toulenga;
- Chief Tapang Tamate, papa blong Simion Mantaura;
- Enadulele blong Savaki, papa blong Kalosike Tuabule;
- Taliemaire blong Malawota hemi marretem Simion Mantaura,; mo
- Toaralesa blong Naeva papa blong Pastor Kalmar.

Olketa Natives blong Tanmiala oli givim ol pieces lands long olketa blong oli work long hem long Paunangisu mo Chief blong Tanmiala hemi givim some titles blong chief too long olketa blong lukaotem olketa people insaed long new community. ## OLKEGA FINDINGS:

### INTRODUCTION:

**Name blong land:** After we Kot ihearem every evidence, kot ifindem se Land we istap long dispute we oli stap kolem "Malasa" or "Malasaliu" hemi receivim name ia followem wan tabu water we istap insaed long area ia. Name blong tabu water ia long language blong North Efate hemi "**Malosa**". Kot ivisitem tabu water ia, hemi tekem bigfalla space mo hemi muddy still kasem tudei. Custom belief blong olketa natives blong ples ia, se water ia hemi save causem death blong anyone we hemi drownem any part blong body blong hem insaed. Mud ia isave kakae skin mo taem oli sikrasem hemi become red sore; isave stap red longtaem, finally taem hemi drae, hemi causem ded blong man/woman. **Red sore long language: Miala moru.**

Olsem plante island long Vanuatu, taem ol whiteman or Missionary ikam askem blong acquirem wan land, olketa natives oli salem tabu ples or rabis ples blong olketa (area we oli no save usum blong mekem garden long hem). So blong identifaem ples ia oli refer long hem olsem Malasa. Hemi karem name ia kasem tudei so Kot ia bambae iusum name ia too.

Malasa iexperience first impact blong development long New Hebrides (colonialism). Insaed long Malasa, yumi save look evidences blong colonial times, olsem village blong Paunagisu we Presbyterian Mission hemi settle long hem blong start imposem new culture blong chritianity mo olketa first business blong commercialization blong coprah long area. Evidence ishowem se igat wan shop/store blong olketa coprah cutters istap close up long Malosa.

Malasa hemi experiensem storian blong blackbirding too. Unlike narafala settlements blong ol Missionaries long Efate, Malasa hemi givim hard time long olketa Missionaries long time ia we imekem se oli must removum olketa earlier Christians igo long wan smol offshore island (Kakula Island) from temptation blong backslidings (igo back long cultural pleasures) blong olketa natives mo mosquitos long tabu water "Malosa".

**Boundaries:** Taem Kot ivisitim land ia, ifindem se hemi wan flat ples, mo iluk olsem hemi followem olketa ples we olgeta natives oli been lendem igo long Presbyterian blong iholem in trust blong protectem from olketa planters long early european settlements. Ol custom boundaries oli ol tris mo fences. Ino gat any natural features blong Land we yumi save lukim blong markem custom boundri. However olketa parties tudei oli save gud olketa wan wan virtual custom boundaries blong olketa. Kot hemi visitim some graves we isave indicatem some settlements blong bifo. Kot hemi visitim too some areas we hemi showem probability se igat Farea long hem bifo colonialism.

Kot ifindem wan striking site we every parties oli agri se hemi grave blong wan "lazy" man. Taem oli smol pikinini ol oldfalla blong olketa oli bin warnem olketa blong no touchem stone we oli plantem long grave ia, sapos no bambae oli save lazy olsem lazy man ia. Logical mo striking part blong site blong lazy man ia, is that, stone we oli putum blong markem grave ia hemi stand high long ground, about 1.20 metres; mo around long stone ia igat about 3 to 4 very old "Namele tris". Anyone isave luk olsem se hemi grave blong wan Paramount chief or Wan



important man blong ples ia. Question istap se why olketa graves blong ol big chieves such as **Chief Manavilalu**, **Chief Lakeleowia**, **Chief Manlaewia** oli nearly lost. Olsem oli markem long ol smol smol stone nomo situated here and there long plantation, but blong "lazy man", hemi "Vatu Farau" (longfalla stone). Hemi more probable se Vatu Farau imarkem stone blong grave blong wan bigman we hemi bin live long area ia bifo. Sapos itru olsem then hemi no save stap stret long boundary mark blong wan kastom ground.

Igat high probability se Malasa hemi no wan kastom land hemwan, but part blong Tanmiala. Mo stret boundary istap long last page blong Judgment ia; mo ol first people we oli populatem Malasa oli kamaot long different area. Majority blong olketa ia oli Naflac Yam.

## ORIGINAL KLEMANT

Long initial stage blong establishment blong Paunangisu village, igat intermarriages mo naflac MALU mo NAWI (yam) irule long disputed area. Famili blong original klemant oli instrumental long decision making and work blong developpem area in dispute so much that generation blong olgeta tudei oli wandem resistem pressure we ikam againstem olketa taem issues blong disputes over ownership blong land istap affectem every man Vanuatu. Infact majority blong olketa man we oli been ordained since estableishement blong Paunangisu kasem tudei, oli born out long naflac YAM. Mo long disputed land ia trifalla persons ia: Toarasariamata, Talieta mo Toara Lessa oli producem every chiefs we villages blong Emua mo Paunangisu istap look up long olkega tudei. Olsem:

- Chief Lakeleowia: through Talieta;
- Chief Manavilalu: through Talieta
- Chief Manlaewai: directly from Toumanu girl blong Toarasariamata;
- Chief Raymond Marongoe: through Talieta;
- Chief Pakoa Maau Nattie: through Talieta;
- Chief Manlaerana Kalnagisu: Through Talieta;
- Chief Peter Maripopongi through Talieta
- Chief Marvatutipua: through Toara Lessa

Igat evidence se chief Manavilalu hemi title blong big chief Tagarasi blong Pele but olgeta land we oli stap work long hem iblong olketa be oli no kastom owners. Long past oli stap givim nasautong long chief Manlaewia.

Olketa chieves ia oli ordained followem naflac blong Toumanu mo Talieta except Marvatutipua we hemi descendant male blong Taora Lessa.

Kot inotem se Original klemant hemi originally claim under Malu famili then hemi recently changem claim under 2 chiefly titles: Manavilalu mo Lakeleowia.

**Chief Manavilalu:** Kot ifollowem bloodline blong Original claimant mo findem se last chief Manavilalu hemi inheritem title ia followem Talieta naflac Nawi, igo down long Leinasei we hemi marretem Rolland Maseitonga, then Flora we imaretem Morris, down to Erina we imaretem Wallace then Silas.



**Chief Lakeleowia:** Kot ifollowem bloodline blong Original claimant mo findem se last chief Lakeleowia hemi inheritem title ia long brother blong Talieta we hemi Toarasariamata naflac Nawi, igo down long Toumanu we imaretem Dick Vakao (Dick Tinapua), then Leisau we imaretem Solomon Manlaewia, then igo long Edward we marretem Winnie mo lastly long Ernest.

Tufalla original chiefly titles ia tufalla ibin sleep over 4 generations. Oli just leftemap bakeken long 5<sup>th</sup> generation igo long Silas Wallas mo Ernest Kaloris. Famili tri we tufalla chieves ia ipresentem ishowem se blood blong Leitalie wetem Lakeleowia istap tudei wetem Marvatutipua Solomon mo Kalmaire.

Igat probability se Manavilalu hemi title blong Pele. History ikamaot se hemi stap providem human flesh long chief blong Pele mo too hemi ordainem chief Tagarasilasa. Manavilalu mo Lakeleowia tufalla ino followem bloodline blong man; but naflac MALU blong original Chief Manavilalu mo Lakeleowia.

Klem blong tufalla chieves olsem "Custom Owners blong Malasa" ino save succeed. However olketa relatives blong tufalla oli holem perpetual rights over long ol piece lands we olketa descendants blong tufalla chieves ia istap work long olketa since village blong paunangisu iestablished long Malasa. Iluk olsem olketa pieces lands ia oli stap long Sepati.

## COUNTER CLAIMANT 1 CHIEF HENRY CYREL MANLAEWIA

Kot ifindem se **Chief Henry Cyrel Manlaewia** iclaim under:

- **Name blong hem "Henry Cyrel".** Bloodline blong Henry Cyrel ikamaot long Mintho McCoy we hemi wan man Norfolk Island. Mr. McCoy hemi gat wan relationship wetem one Dorothy we hemi become wife blong Pastor Kalmara. Mr. Cyrel iborn out long relationship blong Mr. McCoy mo Dorothy. Mr. Cyrel imarretem Anne first born girl blong oldfalla Solomon Manlaewia mo tufalla ibornem Henry. Long saed blong Bloodline blong Henry Cyrel as kastom owner ino save succeed. However hemi Land owner blong olketa eria we hemi inheritem from Solomon (papa blong Anne Cyrel).
- **Title blong hem "Manlaewia".** Kot ifindem se title Manlaewia hemi title blong Naflac Yam. Hemi big chief blong Naflac yam hemi subordinate blong chief Maripongi. Hemi bigfalla chief long area we istap long dispute. Insaed long area ia igat chieves "Manlaewia" Mansanga, Marikinamali, Mansarope, Matsari mo Marvatutipua. Jurisdiction blong Manlaewia iextend igo long Sikia mo Napara including Varea Saipiri. Full disputed area ia hemi governed by title ia.

Furthermore Chief blong Tanmiala hemi save se Chief Manlaewia hemi lukaotem area we hemi stat long varea ni sui kasem Sikia. Nakamal blong hem istap long sikia;

Igat enough evidence blong Kot ideklarem se Henry Manlaewia hemi **custom ruler blong Malasa**. Title Manlaewia hemi never stop blong work/reign. Hem nao



hemi take care long bigfalla boundary blong Malasa within Tanmiala Kastom boundri.

## COUNTER CLAIMANT 2 CHIEF MARIPONGI & VAMELE FAMLI

Counter claimant ia hemi claim under:






