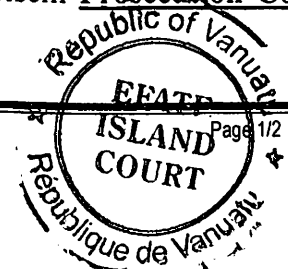
JUDGEMENT


2. Mo must pem **5'000 vatu** olsem **Island Court Fine** (*Count 1 : 3'000vt and Count 2: 2'000vt*) ;
3. Payment must before Thursday 31st day of July 2014 at 16:30pm ;
4. All Payment must be paid directly to the Government Cashier at the Finance Department – Government Building and provide the court and prosecution copy of the payment receipt;
5. Sapos anyone i no happy wetem order ia, hemi gat right blong appeal i go long Magistrate Court within 30 days as from today.
