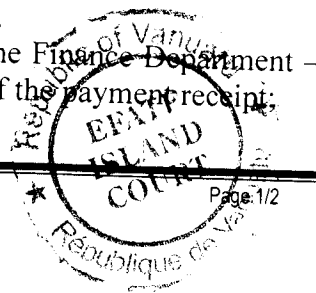
**JUDGEMENT**

4. All Payment must be paid directly to the Government Cashier at the Finance Department - Government Building and provide the court and prosecution copy of the payment receipt;




5. Sapos anyone i no happy wetem order ia, hemi gat right blong appeal i go long Magistrate Court within 30 days as from today.

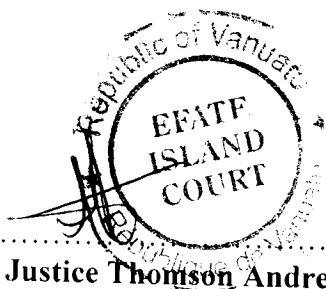
