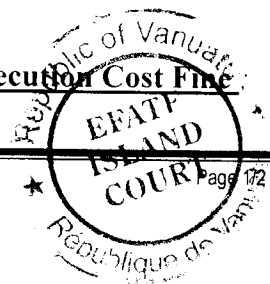
**JUDGEMENT**

**COURT IA HEMI STAP MEKEM ORDER OLSEM:**


1. Defendant ia PALREA MOLISSA i must pem 2'000 vatu olsem **Prosecution Cost Fine**;
2. Mo must pem 3'000 vatu olsem **Island Court Fine**;




3. Payment must be before Thursday 31<sup>st</sup> day of July 2014 at 16:30pm ;

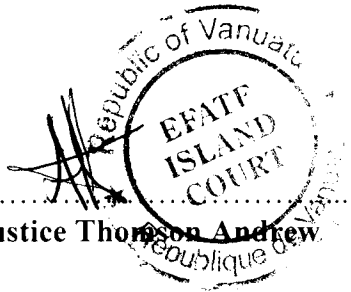
