JUDGMENT

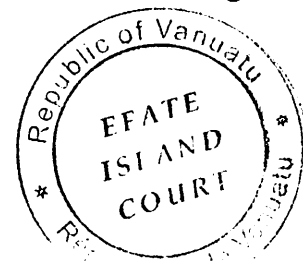

Jimmy hemi stap claim se hemi work blong defendant ia Wendy Himford since 11th April 2015 kasem 20th May 2015 but Mrs. Himford hemi no pemaot ol overtime mo public holiday blong hem.

From reason ia, Mr. Jimmy hemi stap seekim wan order i kam long court ia blong orderem Mrs. Himford blong mas pem hem 15'000 vatu olsem overtime long salary blong hem mo olgeta public holidays plus olgeta cost blong karem kes ia i kam long court ia blong deal wetem.

Plaintiff hemi talem se hemi no saenem any contract wetem Defendant ia Wendy Himford long saet blong work.

Mr. Jimmy hemi confirmem long kot se hemi work blong Mrs. Himford long wan daily hourly rate nomo.



Issues:

3. Wether Wendy Himford hemi fail blong pem overtime mo public holiday blong Mr. Jimmy;

Findings:

COURT ORDERS:

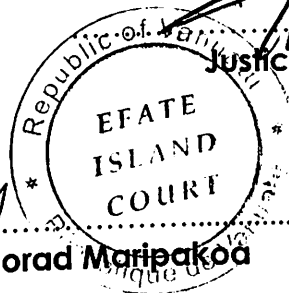
