## **NEM BLONG LAND CLAIM : MALAWORA LAND**

Bifor kot isitaon blong harem kes ibin kat short conference wetem ol parties long kes. Long taem ia kot iaskem ol parties sipos oli kat any objection long composition blong kot be everywan ihapi blong ol justice mo presiding Magistrate ia oli save sit daon long kes ia.

Ibin kat wan application ikam long kot long counter-claimant no.3 blong askem wan order blong stopem ol parties or any person we oli stap receivim ol proceeds (money) long ol development insaed long land ia Malawora. Mo tu ikat nara issue hemi blong stopem ol development in saed long land ia.

Kot imekem order olsem: -

*"Hemia hemi wan application we George Sokomanu representative of Family Masaii hemi mekem blong restrainem every party blong no mas receivim any proceeds long any piece of land insaed long Malawora land kasem taem kot imekem decision long custom owner. After long hemia Simeon Poilapa hemi askem kot to blong restrainem ol man blong no mekem development long land ia Malawora.*

4. Taem ol person ia we oli stap pem money ia long account imas talem long bank se money ia iblong **Malawora land** so that bae ikam aot long statement of account blong Supreme Court Trust Account.

Clerk hemi no bin advertisem notice blong hearing mekem se Kot hemi no save refusem application ia. Mo storian we bae ol parties oli talem long kot blong pruvum se who nao iraet kastom owna blong land ia bae i kam aot nomo long kastom blong yumi long Efate.

### **Komposition blong Kot**

Long Amendment Act No.35 blong 1989, Parliament i bin pasem se anda long sekseen 2 blong Aelan Kot Act, CAP 167, taem we Aelan Kot isitaon blong harem dispiut long land bae wan Magistret i mas sitaon wetem trifala Aelan Kot Jastisis. Anda long sekseen 2(a) blong Act ia, wan

Magistret olsem bae ino save sitaon sapos Jif Jastis ino kivim authoriti long hem. Folem hemia Kot i wandem talem long ol patis se olgeta we oli deal wetem kes blong Malawora Land oli qualifae evri wan.

**Brief history blong kes ia:**

Island Kot Clerk hemi publishim notice blong land ia long wan manis according long law blong Island Kot Act CAP 167 long Order 6 Rule 8 mo 9. Family Nikara, Family Lakelo Taua Manawora, Family Masai mo Family Mariki Langani Vate Lapa, oli aware long land claim ia oli counter claimem land ia mo oli faelem kes blong olgeta mo pem fees.

Bifo kot iharem substance blong case kot ibin explain gud long ol patis se land case hemi important long laef blong wanwan man we iting se ikat raet blong onem land ia mekem se ol patis oli mas andastand se hemi impotent se olpatis oli mas helpem kot blong kot ihelpem olgeta. Long Namba 17 January 2006 kot isidaon blong harem sabstance blong land kes ia. After family Thesa Anatu ijoint olsem new party nao ikat parties mo kot ikohed mo harem kes.

After kot ikivim oda blong stopem ol parti blong no collectem money Family Nikara ideside blong no kam long substantive kes. Inokat wan long ol family Nikara ikam long kot blong talem long kot se oli withdraw long kot so kot iko ahed blong harem kes be kot ino withdraw family Nikara. Family Nikara istil stap olsem wan parti blong kes.

Tufala olfala itekem aot olfala woman ia oli aot long La Cole River oli folem creek we oli kolem Tebainiwe emi olsem wan point iko kamaot stret long river, oli ko kasem Green Taon after oli ko kasem antap long Tepukoa river, ples we oli bin stap wasem leg blong olfala woman ia long hem. Sobuso wetem brata blong hem Tastuki mo ol pipol blong hem oli katem sam white wood mo mekem kenu mo oli bul iko long Sonnago Point mo oli pul iko across iko daon long smol island Imere Tenuku we oli kolem nao Hide Away mo oli kam shore long Falekapau mo jif Sobuso wetem woman blong hem Leivoasa Leinaika mo brata blong hem Tastuki oli wokem wan bigfala haus blong olgeta mo oli singaotem haus ya Safalapa we hemi nem blong bigfala nasara blong olgeta antap long Savarewo insaed long Sonno Area.

Long taem ia Masikoto hemi tes kam back long T.T.I. so wetem help blong ol missionary oli putum Masiko hemi kam namba 2 jif blong Imere Tenuku.

Namba two witness hemi Kaltchichi Novi Natokora. Witness ia hemi blong givem evidence long saed blong family tree. Taem blong cross examinations ol spokes man oli askem questions concerning witness ia nomo mekem se hemi no tok about full family tree blong family Subuso. Witness No. 3 hemi Mr Daniel Lamurre. Witness ia italk about Sale of land long Malawora, Long evidence blong hem hemi talem se taem ol waet man oli kam oli askem Sibuso we ol waet man ia oli colem hem Alorgali Carpenter Thomas Long. Hemi talem tu se hemi pem graon long area blong Malawora from se uncle blong hem ilettem long hem mo talem se iko stap long hem from hemi a iples blong olgeta.

After threefala witness ia oli givim evidence spokes man iko long witness box mo ol nara parties oli cross-exminanem hem tu.

Kot ibin livim iopen long Family Nikara blong kam back long kot any time because oli no bin askem blong withdraw formally olsem wan party long kes.

Kot ikohed blong harem kes. After we kot iharem every party Family Nikara ikam back mo askem blong hemi mekem kes blong hem. Kot lialaoem family Nikara blong mekem kes blong hem.

Family ia imekem application blong crss-examinanem olgeta witnesses blong ol nara parties. After kot iharem response blong ol nara parties imekem decision se applicaton ifail. Kot ino aceptem application blong hem mo iexplain long hem se hemi lusum sam rights blong hem olsem bae hemi no save question olget witnesses blong ol nara parties because hemi choose blong no attendem kot taem olgeta oli mekem kes blong olgeta. Be ol nara party oli save questionem olgeta witnesses blong hem. So hem gohed blong mekem kes blong hem.

Hemi jif mo emi muv wetem people blong hem long ol different settlements ko kasem Imere Tenuku. Long presentation blong hem hemi talem se hemi kam long kot blong defendem land blong hem we hem Savarewo. Hemi talem se land ia ino Malawora be hemi Savarewo. Hemi talem se hemi bin party long kes blong Marobe from se hemi defendem land blong hem we hemi Savarewo, mo long taem ia kot ibin mekem order mo givem sam pis lan long family Nikara long area blong Malawora land. Hemi bin callem one witness be witness blong hem italem se hemi kam blong kot blong talem se land hemi no Malawora be Savarewo. Kot

ino save rely long evidence blong hem tumas from hemi talk abaot Savarewo we hemi nara nem other than hemia we kot isidaon from we hemi Malawora. Hemia hemi second hearing blong kes ia and sipos kot ino understandem from sipos issue blong nem blong land ikam aot long fes hearing oli shud sortem aot finis. After witness ia Spokes man iko long witness box mo hem tu italk about Savarewo mo argue se land hemi no Malawora. Kot iaskem hem wan question olsem "yu kam long kot from land ia Malawora from yu luk oli advertasem mo yu kam." Be hemi talem se no hemi kam long kot blong defendem Savarewo. After long kot Spokesman ibin folem wokabaot long fes day be hemi no kam long second day we hemi sapos blong shoem kot area we hemi klemem. Mekem se kot hemi kat daot se hemi ownem wanem lan mo wea.

Long presentation blong family Masaai oli talem se Masaai hemi wan big jif mo bigfala traeb oli stap wetem hem. Oli talem se Masaai family istap wetem 14 nara family or tribe oli behind long hem. Generation blong hem istat long Masaai 1 kasem Masaai 9 mo tedei Masaai 7 nao istap lidim tribe. Oli talem se Masaai 1 ibon araan late 1600s. Masaai mo family wetem ol 12 tribal family blong hem we oli klemem graon ia we oli kolem Malawora se emi tru kastomary graon blong olgeta mo olgeta nao oli stret kastom ona long graon ia. Malawora emi stap bitwin tufala river ia Tesono wetem Tepukoa.

Masaai hemi wan paramaon jif insaet long family tribe blong hem mo hemi kat ol pipol blong hem we oli folem hem aot long dak bush ikam daon long Malawora. Ikat 12 families istap insaek long traebal famili ia blong Masaai we I exist since taem immemorial kasem tedei. Hemi kat spoksmen blong tok long bihaf blong hem. Hemi kat warrior blong lidim faet, hem ikat ol kleva blong hilim man mo tu lukluk sapos ol samting iolraet or no mo ol scout blong checkem ol ples fastaem bifo muvmen iko. 


