**JUDGMENT**


**Brief backgraon blong case:**

Civil Case # 01/2012 hemi wan customary matter concernem dispute long Jifly taetol blong Mahawi Tribe, hemia long North West "A", Malekula. Court hemi bin arem case ia mo tekem daon every points blong tufala parties blong jastifaem issue we istap.

**Issue:** Whu nao long tufala claimant ia istret man blong karem taetol blong Paramount Jif blong Mahawi Tribe?

**Smol Histri blong case:**

Original Claimant – Tuptik Niptik hemi stap talem long histri blong hem se, bifo we ikam papa blong hem nao i wan paramount chief blong Amokawai. Taem hemi muf iko long solwota, hemi nomo kilim namangi from hemi jensem laef blong hem folem fandamento biliv blong SDA church. Taem oli sentem toktok from hem blong kampak kilim Namangi long Amok, hemi tekem brata blong hem (Japeth) mo tufala ko be hemi no drink kava mo oli no talem anything lo hem nomo taem oli sta lo nakamal. Taem tufala sta kopak lo solwota, olfala Lakon wetem Shmrn oli biaenem tufala kasem lo Tenamet, olfala Lakon isingaotem papa blong OC afta hemi katem stampa blong Namambe. Hemi talem long hem se bae hemi mas kampak long kastom blong kivim pak kaon blo chief blo Amok. Be papa blo Tuptik Niptik i talem lo brata blo hem(Shmrn) se bae hemi akt lo biaf blo



hem blo kivim pak kaon ia. Afta long hemia hemi talem lo Shmrn se spos wan pikinini or any generesen afta long hem, bae hemi nomas kilim any namanki from hemi acting nomo. Original Claimant hemi konkludum mo talem se, "kam kasem tete boe blong Marcella istill kilim namanki be hemi no tingbaot ol toktok we papa blong hem ibing talem long olketa". Risen ia nao mekem se OC hemi klem taetel ia we ilaeif istap lo papa blong hem yet.

Counter Claimant(1) – Ravutik Song Pierre hemi stap klemem blad laen we chief hemi wok folem. Hemi se Avihambath Horambath nao hemi laef blad blong Mahawai kam kasem tudei we hemi kat 12 Generesen. Hemis talem tu se Vinsei we hemi mama blo Elaeja, hemi kat bel finis taem we hemi ronwe lo Tenmaru mo kam stap wetem chief Avihambath namba 4 waeblong hem. Hemis konteniu blong talem se mama blong hemi klemem chiefly taetel blong Mahawai from, hem nao, istret pikinini blong chief Arnham bath we istret laef blad blong Mahawai be, ino papa blong Tuptik Niptik.


#### Family Tree:

Wetem ol toktok ya court i notem ol points ia;

1. Kot I faenemaot se youtufala, chief Tuptik Niptik wetem Marcella Horambath, youtufala I brata nomo olsem we famli tri blong youtufala I soem mo ol witniss tu oli prufum long kot ia.
2. Kot I faenemaot tu se dispiut blong youtufala brata, Jif Tuptik Niptik mo Jif Marcella Horambath hemi from two(2) difren raets;
  - a) Jif Tuptik Niptik yu klem toktok we Jif Alaeja Niptik I talem long Shmrn se bae I acting long biaf blong hem olsem paramount Jiv blong Mahawai blong kivim bak ol kaon blong Jif blong Amok
  - b) You Jif Marcella Horambath you klem raet ia we you talem se Jif Alaija Niptik I angem tawel long Jif Hranambath mo talemaot pablikli long nakamal se raet ia we you karem hemi blong you we Jif Alaija Niptik I kivim bak long you.
3. Kot I harem se Jif Marcella Horambath wetem sam long ol witniss blong hem oli talem long kot ia se, Alaija Niptik hemi no blad laen blong Avihambath.
4. Kot I arem long counter claimant wetem ol witniss blong hem se Alaija Niptik hemi paramount Jif blong Mahawai.
5. Kot I harem long witniss bong original claimant (Japeth) se hem ia nao hemi eye witniss mo hemi witnisim ol toktok we Jif Alaija Niptik hemi talem long Lakon mo brata blong hem Shmrn.
6. Kot I harem ol witniss blong tuketa saet se jif Alaija Niptik nao hemi fes bon long family.



7. Kot I arem long witniss 2 blong counter claimant se Alaija Niptik hem I paramount Jif blong Mahawai from hemi bon insaet long aos blong Jif Virhambath.
8. Kot I harem long witniss 2 blong counter claimant se kastom Nal Nal hemi wot long kastom blong save tekemaot raet ia iko long wan nara memba blong family be ino tawel mo mani we istap long statement.
9. Kot hemi harem se from we Alaija Niptik hemi fes bon long family mekem se Jif Avihambath I putum hem olsem paramount Jif blong Mahawai.
10. Kot I harem se pupu blong Jif Tuptik Niptik hemi kilim 500 pigs.
11. Kot I harem se Jif Aranhambath I kilim namanki 6 taem long Mahawai wetem sam tambu kastom ceremony we Jif I mekem olketa olsem big Jif blong Mahawai.

#### **Law we Court I applaem:**

CAP 167 (s.10) – Application of customary law

Subject to the provisions of this Act, an island court shall administer the customary law prevailing within the territorial jurisdiction of the court so far as the same is not in conflict with any written law and is not contrary to justice, morality and good order.



Afta we kot I arem Original Claimant wetem Counter Claimant (1) mo ol witniss blong tufala, kot I wantem talem long Jif Marcella se ol witniss we oli kam blong witnisim blad laen ia, ino kat wan long ol witniss ia ikam long Tanmaru (plies blong mama blong Alaeja Niptik) blong talem long kot ia se, hem nao, hemi laef blad laen blong Jif Alaeja Niptik we I laef yet tete long vilij blong Tanmaru.



**Decision:**

1. Wetem ol toktok ia, kot hemi kam blong Dikliarem tudei 9<sup>th</sup> dei blong Novemba 2012 se Original Claimant, Tuptik Niptik nao, hemi Paramount Jif blong Mahawai Tribe.
