Brief backgraon blong case:


Civil Case # 1/2013 hemi wan customary matter concernem dispute long Jifly taetol blong Bik nakamal Mulei long Vao aelan. Keis hemi kam bifo long kot long 8/04/2013 mo tudei 27/08/2013 keis hemi ko long trial blong faenemaot issue we istap.

Issue:

Who nao long olketa parties ia hemi raet man blong tekem taetel ia olsem stret jif blong Bik Nakamal Mulei?

Smol Histri blong case:

Original Claimant – OC hemi talemaot long kot ia se hem nomo hemi rulum every nakamal insaet long Labbarang, nasara blong Betehul village. Taem kot mo ol paties oli kwistinim hem, hemi talemaot se; yes Mulei nao hemi bik nakamal insaet long nasara from ston blong hem istap long foret mo Molei hemi wan saet ston blong hem we tufala istap insaet long Labbarang. Hemi talemaot se ikat 8 nakamal everyone we istap insaet



long Betehul be oli nomo luk save hem olsem bik jif. Logh-Vali hemi no wan nakamal, hemi nem blong wan man we hemi ansestas blong hem. Long kastom blad laen fes bon nao hemi kamaot long hem we family tri blong hem isoemaot klia. Hemi koet blong talem se, Namangi hemi kill insaet long nasara mo sekomcisen & miting blong every smolsmol jifs istap apen insaet long nakamal blong hem. Meltegani nao hemi head blong Nakamal ia (Bik Nakamal Mulei).

Fes witnis hemi Jeannot Malcekan we hemi kam long kot ia blong witnisim family tri blong hem mo high rang ia we olfala blong hem itekem.

Taem kwistin hemi reis, ikam blong talemaot se 1 man nomo hemi brid iko long 4 nakamal ia mo insaet long olketa, ikat ol smolsmol nakamal pakeken (1 blad nomo insaet long ol nakamal ia).



Counter Claimant 3: Robert Amet hemi talemaot se kastom kreif blong hem isilip long Labbarang we tufala nakamal blong hem istap insaet, Logh-Vali mo Mulei. Hemi blad laen blong jif mo hem nao ikasem high rang ia we ikat 6 step long hem. Also hemi se posisen blong ston blong hem hemi stap long fran. Hemi konfemem pakeken long wan kros examinesen se kreif blong papa blong OC istap insaet long Mulei mo blong Amet istap aotsaet long kraon blong bik nakamal. Hemi diskraebem se hem nao hemi las bon disenden blong man ia we ikamaot long rob therefore hemi establish long smol nakamal tudei.

Ricky Coline. Witnis ia ikam bifo long kot blong talemaot se anding ova long posisen ia we Amet imekem iko long OC from nomo, ol pikinini blong hem oli smolsmol yet mekem se hemi mekem olsemia. Hemi mekem lo sence se, sipos oli bikbikwan inaf, OC hemi mas kivim pak ikobak long olketa. Tudei, OC hemi nomo kivimbak afta hemi klem se taetel ia hemi blong hem we hemi no sud mekem olsemia.

2. ISLAND COURT DECISION


Jifly taetel blong Bik Nakamal Mulei hemi transfea ikobak long North East Area kaonsel of Jifs.


3. ISLAND COURT DIRECTION ORDER


