

DECISION

Having heard Mr Kalsakau on an application filed on 28th April 2016 seeking Orders of Corrigendum in respect of the Judgment dated 27th November 2012, And upon hearing Mrs Nari in a brief response,

It is decided and Ordered that-

- 1. The application is proper in the circumstances and is hereby allowed.
- 2. The order sought is granted.
- 3. There is an obvious error as a result of a slip in paragraph 17 of the judgment.
