JOINT REGULATION 20 of 1973

JOINT REGULATION

No. 20
of 1973.

To bring into effect the Estimates of revenue and expenditure of the Joint Administration for the year 1973.

[Published: Condominium Gazette, No. 326.]

MADE by the Resident Commissioners under the provisions of Article 2 (2), 5 and 7 of the Anglo-French Protocol of 1914 and of section 5 of the Joint Finance Regulation No. 10 of 1957, after consultation with the Advisory Council and the approval of the Governments of Her Majesty and the French Republic.

1. The estimates of revenue and expenditure of the Joint Administration for the year 1973 shall comprise—

Estimates of
revenue and

- (a) revenue to the amount of three million two hundred and eighty-two thousand and forty pounds Sterling (£Stg.3,282,040);
- (b) expenditure to the amount of three million two hundred and eighty-two thousand and forty pounds Sterling (£Stg.3,282,040);

or in each case the equivalent thereof in New Hebridean francs.

2. There shall be issued from General Revenue and other funds of the Joint Administration and applied for the service of the year ending on the 31st day of December, 1973, sums not exceeding the amount specified in paragraph (b) of section 1 and the same shall be appropriated as set out in the Schedule to this Regulation.

3. The Resident Commissioners may jointly authorise the Condominium Ordonnateur and the Condominium Treasurer to control expenditure, each according to his responsibilities as set out in Joint Standing Order No. 4 of 1957, within the limits fixed by such authorisation and such expenditure shall not exceed the sums specified in paragraph (b) of section 1.

4. This Regulation may be cited as the Joint Appropriation (1973) Regulation No. 20 of 1973 and shall come into operation on the date of its publication in the Condominium Gazette.
