**1 Amendment of the Business Licence Rule No.2 of 2002**

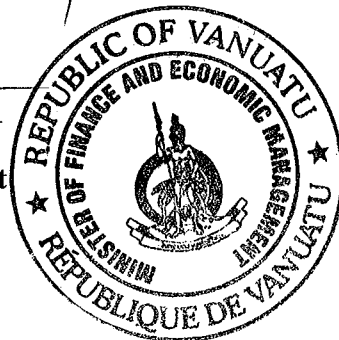
The Business Licence Rule No.2 of 2002 is amended as set out in the Schedule.
