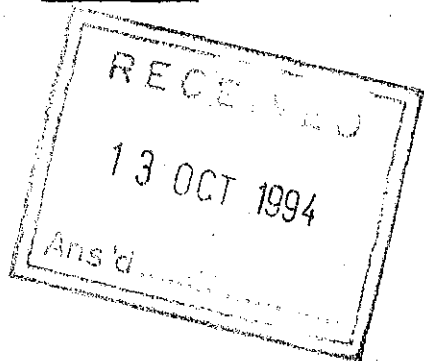

DECENTRALIZATION AND LOCAL GOVERNMENT REGIONS  
ACT NO. 1 OF 1994

LOCAL GOVERNMENT COUNCILS (PROPERTIES OF DISSOLVED COUNCILS)  
REGULATIONS NO. 28 OF 1994

To make provision for the properties of dissolved councils.

**DEFINITIONS**

1. In these regulations -

"Act" means the Decentralization and Local Government Regions Act No. 1 of 1994;

"dissolved Councils" means the Banks/Torres Local Government Council, Santo/Malo Local Government Council, Aoba/Maewo Local Government Council, Malekula Local Government Council, Ambrym Local Government Council, Paama Local Government Council, Epi Local Government Council, Tongoa/Shepherds Local Government Council, Efate Local Government Council, and TAFEA Local Government Council established under the Decentralization Act [CAP. 127] and dissolved by the Local Government Councils (Dissolution) Order No. 25 of 1994.

**PROPERTIES OF FORMER COUNCILS TO BE VESTED IN NEW COUNCILS**

2. All property, real and personal, including all book debts and rights owned by the dissolved councils or to which they were entitled on the 15th day of September, 1994 and all liabilities and obligations of or owed by the dissolved councils on that date are hereby vested in the new Local Government Councils established under the Act for those regions in which the dissolved councils were situated.

~~SECRETARIES TO BE RESPONSIBLE FOR THE CARE AND CUSTODY~~  
~~OF ALL PROPERTIES~~

3. (1) The Secretaries of each dissolved council specified in the Schedule or any public servant appointed by the Minister for the purpose in place of a secretary in any dissolved council region shall be responsible for the control and safe custody of all property referred to in regulation 2 pending the establishment of the new local government councils and shall be entitled to give a valid receipt therefor.

- (2) Any person in possession of any property of any dissolved council shall deliver it to or in accordance with the instructions of the Secretary or public servant concerned.
- (3) Upon being required so to do by the Minister of Finance, the Secretary or public servant concerned shall deliver all such property to or in accordance with the instructions of the Chairman of the Local Government Council elected under the Act.

**PROPERTIES TO VEST IN THE GOVERNMENT PENDING ESTABLISHMENT  
OF COUNCILS**

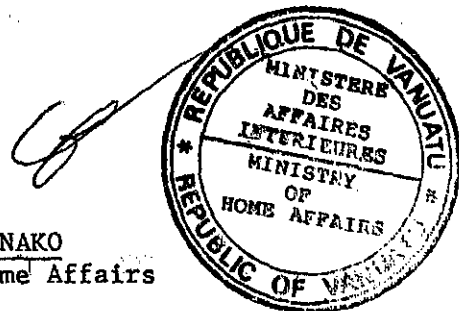
4. All property referred to in regulation 2 shall vest in the new local government councils to be established under the Act and pending the establishment of such councils all such property shall vest in the Government.

**COMMENCEMENT**

5. These Regulations shall be taken to have come into force on the 15th day of September, 1994.

REGLEMENTS NO. 28 DE 1994 RELATIFS  
AUX CONSEILS PROVINCIAUX (BIENS DES CONSEILS DISSOUS)

Prévoyant les dispositions régissant les biens des Conseils dissous.

**DEFINITIONS**

1. Dans ces Règlements :

"Loi" (Act) désigne la loi No. 1 de 1994 relative à la Décentralisation et la création de Provinces ;

"Conseils dissous" (dissolved Councils) désigne les Conseils provinciaux des Banks/Torres, Santo/Malo, Aoba/Maewo, Malekula, Ambrym, Paama, Epi, Tongoa/Shepherds, Efate et TAFEA créés sous l'autorité de la loi No. 11 de 1980 relative à la Décentralisation (CAP. 127) et dissous par l'Arrêté No. 25 de 1994 (dissolution) relatif aux Provinces.

**BIENS DES ANCIENS CONSEILS DEVOLUS AUX NOUVELLES PROVINCES**

2. Tous les biens immobiliers et mobiliers, y compris toutes les créances et tous les droits appartenant aux Conseils dissous ou auxquels ils avaient droit au 15 septembre 1994, et toutes les responsabilités et obligations des Conseils dissous ou dues par ces derniers à cette date, sont par les présentes dévolus aux nouveaux Conseils créés conformément à la Loi, pour les régions dans lesquelles se situent les Conseils dissous.

**GARDE DE TOUS LES BIENS CONFIEE AUX SECRETAIRES**

3. 1) Les secrétaires de tous les Conseils dissous, spécifiés à l'Annexe ou un fonctionnaire nommé à cette fin par le Ministre, à la place d'un secrétaire dans tout conseil dissous, sont responsables du contrôle et du dépôt de tous les biens dont il est question à l'article 2 en attendant la création des nouveaux Conseils, et ils seront habilités à en donner une quittance valable.

2) Toute personne qui a en sa possession un bien appartenant à un Conseil dissous doit le remettre au secrétaire ou fonctionnaire compétents ou conformément à leurs directives.

- 3) Le secrétaire ou fonctionnaire en question, sur demande du ministre des Finances, remet tous lesdits biens au Président du Conseil provincial élu en vertu de la Loi ou les remet conformément à ses directives.

**BIENS DEVOLUS A L'ETAT EN ATTENTE DE LA CREATION DES CONSEILS**

4. Tous les biens prévus à l'article 2 sont dévolus aux nouveaux Conseils provinciaux qui seront créés en application de la loi, et dans l'attente de la création desdits Conseils les biens sont dévolus à l'Etat.

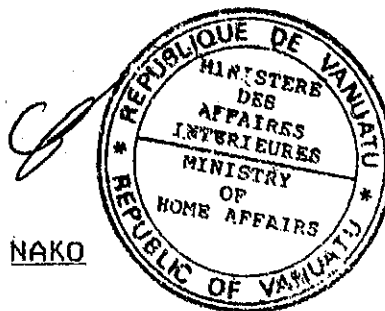
