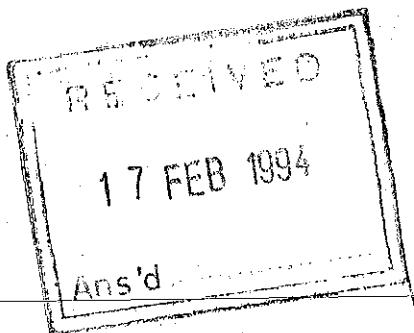

CHAPTER 118

APPOINTMENT OF THE ATTORNEY GENERAL

WHEREAS Article 37 of the Constitution provides (inter alia) for the Speaker of Parliament to perform the functions of the President of the Republic when there is a vacancy in the office of the President;

WHEREAS the Office of the President of the Republic is vacant;

WHEREAS the Speaker of Parliament is now performing the functions of the President of the Republic;

WHEREAS subsection (1) of section 2 of the Law Officers Act [CAP 118] provides for the President of the Republic to appoint the Attorney General on the advice of the Prime Minister;

WHEREAS the post of the Attorney General of the Republic is vacant;


AND WHEREAS the Prime Minister has advised the Speaker in his capacity as the acting President of the Republic regarding the appointment of the Attorney General;

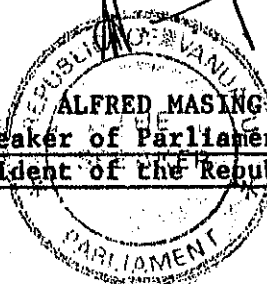
NOW THEREFORE in exercise of the power conferred by subsection (1) of section 2 of the Law Officers Act [CAP 118], I hereby appoint

PATRICK ROBERT ELLUM

Attorney General of the Republic of Vanuatu for a period of 2 years with effect from the 3rd day of February, 1994.

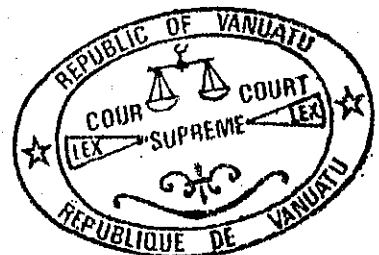
OFFICIAL OATH
