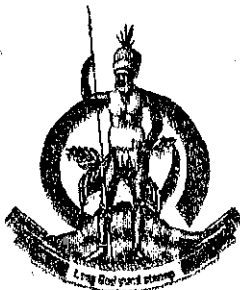

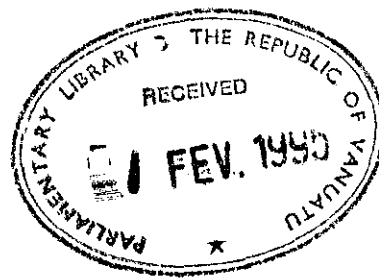

CHAPTER 126

MUNICIPALITIES (DATE OF ELECTION OF  
LUGANVILLE MUNICIPAL COUNCIL) ORDER No. 1 OF 1995

To declare the date for the start of elections of councillors to the Luganville Municipal Council.

IN EXERCISE of the powers conferred upon the Electoral Commission by section 7(2)(a) of the Municipalities Act [Cap. 126], the Electoral Commission, hereby makes the following Order:-

**DATE OF ELECTION**

1. The election of councillors to the Luganville Municipal Council shall commence on 31 January, 1995.

**RETURN OF CANDIDATURE**

2. Eligible persons in the Luganville Municipal Council area may submit their declaration of candidature for the Luganville Municipal Council Election as from the 5th day of January 1995 until not later than 4.30 p.m. on the 13th day of January, 1995 to the Principal Electoral Officer in Vila or to the Town Clerk in Luganville.

**COMMENCEMENT**

3. This Order shall come into force on the date of its signature.

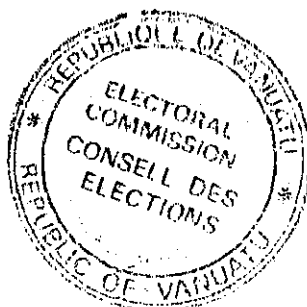

**DATE DES ELECTIONS**

2. Toute personne éligible au Conseil municipal de Luganville peut soumettre, au secrétaire du bureau de l'élection à Vila ou au Secrétaire général de la Mairie de Luganville, sa déclaration de candidature pour l'élection du Conseil de Luganville à compter du 5 janvier 1995 jusqu'au plus tard le 13 janvier 1995 à 16h30.

CHAPTER 86

PRICE CONTROL (PRICES ADVISORY COMMITTEE)  
REGULATIONS NO. 2 OF 1995

To provide for members of the Prices Advisory Committee and for connected purposes.

IN EXERCISE of the powers conferred by section 15 of the Price Control Act [CAP. 86], I SERGE VOHOR, Minister of Economic Affairs, make the following regulations:-

**DEFINITIONS**

1. In these regulations, unless the context otherwise indicates:-

"Committee" or "Prices Advisory Committee" means the Prices Advisory Committee established by section 6 of the Price Control Act [CAP. 86];

"Minister" means the Minister for the time being responsible for price control.

**COMPOSITION OF PRICES ADVISORY COMMITTEE**

2. (1) The Prices Advisory Committee shall consist of a chairman and four (4) other members appointed by the Minister and shall be composed as follows -

- (a) a member who is a representative of importers;
- (b) a member who is a representative of (traders);
- (c) a member who is a representative of consumers;
- (d) a member who is an officer from the Department of Economic Affairs who shall be the Vice-Chairman; and

- (e) a member who is a representative of the Ministry responsible for price control who shall be the Chairman.
- (2) The term of office for a member is three (3) years and a member is eligible for re-appointment.
- (3) A member may resign his office by giving not less than thirty (30) days notice in writing to the Minister.
- (4) The Minister may -
  - (a) remove a member from office by notice published in the Gazette;
  - (b) terminate the appointment of a member or the nomination of an alternate member who is absent from three (3) consecutive meetings of the committee without having informed the chairman prior to the meetings.
- (5) The Minister on appointing a member may nominate an alternate member to act in the place of the appointed member when the appointed member cannot perform his duties due to absence from Vanuatu or incapacity due to illness.
- (6) An alternate member when acting in the place of a member shall enjoy all the rights and privileges of the member he represents.
- (7) All appointments and nominations made under this regulation must be published in the Gazette.

#### MEETINGS OF THE COMMITTEE

- 3. (1) Meetings of the Committee will be held at such times and places as the chairman may determine from time to time provided there are not more than ten (10) meetings in each year and reasonable notice of each meeting is given to each member.
- (2) The quorum of meetings of the Committee will be four (4) members including the Chairman or the Vice Chairman.

- (3) The chairman or in his absence the Vice Chairman will preside at every meeting of the Committee.

**SITTING ALLOWANCES**

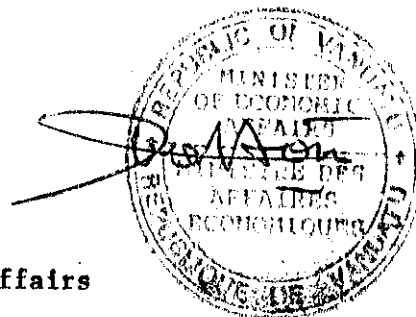
4. (1) A member of the Committee is entitled to a sitting allowance for each day or part of a day that the Committee sits at the following rates-
- (a) chairman, 3000 Vatu; and
  - (b) a member, 2000 Vatu.
- (2) The sitting allowances referred to in subregulation one (1) will not be paid to members who do not attend the sitting.

**COMMENCEMENT**

5. These Regulations shall come into force on the date of their publication in the Gazette.

CHAPTER 168

OFFICIAL SALARIES ORDER NO. 3 OF 1995

To amend the Schedule to the Official Salaries Act [CAP. 168].

IN EXERCISE of the powers conferred upon me by section 3 of the Official Salaries Act [CAP. 168], I, MAXIME CARLOT KORMAN, Prime Minister and Minister of Public Service, Planning and Statistics, Media Services and Language Services, with the prior approval of the Council of Ministers, hereby make the following order: -

**AMENDMENT OF PART 1 OF THE SCHEDULE TO CHAPTER 168**

1. Part 1 of the Schedule to the Official Salaries Act [CAP. 168] in this order referred to as "the Act" is amended -

- (a) in column 3 by adding at the end of the items corresponding to the office of the "Chief Justice" in column 1 the item "M";
- (b) in column 3 by adding at the end of the items corresponding to the office of the "Public Prosecutor" in column 1 the item "M";
- (c) in column 2 by deleting the figure "1,437,504" corresponding to the office of the "Principal Administrative Officer to the Prime Minister" in column 1 and substituting the figure "1,684,584";
- (d) in column 2 by deleting the figure "806,952" corresponding to the office of "Secretary/Typist to the Council of Ministers" and substituting the figure "809,496".

**AMENDMENT OF PART 2 OF THE SCHEDULE TO THE ACT**

2. Part 2 of the Schedule to the Act is amended by adding after "CLASS L" the following class -


"CLASS M

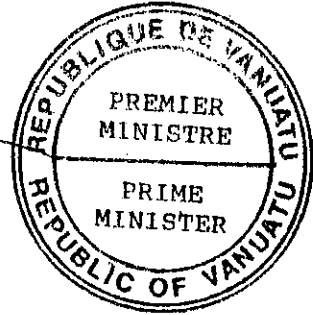
Where the holder of the office is a non-citizen not funded by any other government or agency, an annual overseas officers allowance agreed by the Minister of Justice with the approval of the Council of Ministers."

COMMENCEMENT

3. This order shall be deemed to have come into force on the 1st day of January, 1995.

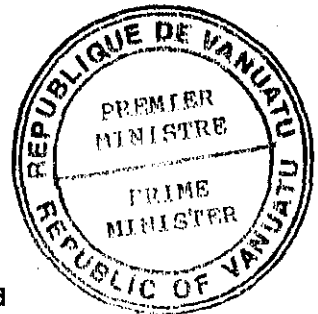
