**1. Interdiction de la vente des boissons alcoolisées à Vanuatu**

La vente, la fourniture et la distribution des boissons alcoolisées dans les établissements agréés dans tout l'archipel de Vanuatu, que ce soit pour consommer sur place ou à l'extérieur des établissements, sont par les présentes interdites à partir de 6 heures du soir 27 juillet jusqu'au lundi 30 juillet à 12 heures du soir.

**2. Exemption**

Les boissons alcoolisées peuvent être vendues conformément au paragraphe 1), au cours de ladite période dans les boîtes de nuit, restaurants et hôtels aux heures d'ouvertures afin d'autoriser les clients à consommer.

**3. Entrée en vigueur**

### COMMISSIONS OF INQUIRY ACT [CAP 85]

#### Appointment of Commission of Inquiry Order No. 58 of 2001

In exercise of the powers conferred on me by subsection 1(1) of the Commissions of Inquiry Act [CAP 85], I, Edward Natapei, Prime Minister and Minister responsible for Justice, make the following Order:

##### 1 Definition

In this Order, unless the contrary intention appears:

“Commission” means the Commission of Inquiry established by this Order.

##### 2 Appointment of Commissioner to the Commission of Inquiry

Sampson Ngwele is appointed as the Commissioner of the Commission.

##### 3 Appointment of Assessors

The following persons are appointed as Assessors of the Commission:

(a) David Seule;

(b) David Adams.

##### 4 Appointment of Secretary to the Commission of Inquiry

The Minister is to appoint a Secretary to the Commission not later than 7 days after publication of this Order in the Gazette.

##### 5 Terms of Reference

- (1) The Terms of Reference of the Commission are as set out in Schedule 1 of this Order.
- (2) The Terms of Reference of the Commission may be amended or varied by the Minister in consultation with the Commissioner.

## **6 Location of Inquiry**

The inquiry is to be made in Port Vila and at such other place or places as the Commissioner may determine.

## **7 Public or Private Inquiry**

The inquiry is to be held in public except in circumstances as directed by the Commission.

## **8 Reports**


The Commissioner must prepare the following reports:


- (a) a report of the proceedings and of the result of his inquiry to the Prime Minister, as the Minister of Justice not later than 24 September 2001.
- (b) a report summarizing his findings and his recommendations available to the public not later than 14 days after the date of submission of his report to the Minister.

## **9 Commencement**

This Order commences on the day on which it is made.

## SCHEDULE 1

### Terms of Reference

#### **MV KIMBE**

- 1 To inquire into the circumstances surrounding the foundering, stranding and a major fire on board the MV Kimbe on or about 10 July 2001, including:
  - (a) Any factors affecting the departure and the actual conduct of the voyage, including the weather conditions, the seaworthiness and capability of the vessel, its navigation and the possible sequence of events on the vessel before it foundered, stranded and was on fire;
  - (b) The management, operational and maintenance support provided by the owners and operators of the vessel;
  - (c) The management and operational support provided by the Government agencies to assist the safety of navigation, including navigational aids.
- 2 To recommend any improvements that are required in:
  - (a) Laws and rules relating to navigation throughout Vanuatu and the roles to be played by Government agencies;
  - (b) Standards to be applied, resources and equipment required to be provided on vessels, operating throughout Vanuatu;
  - (c) Any other matter that the Commission deems appropriate.
