1 Temporary closure

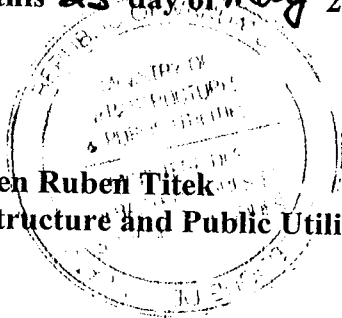
