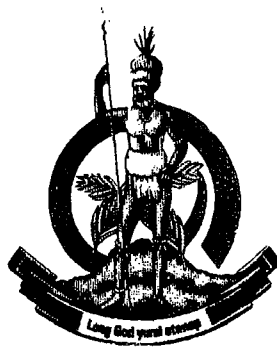

#### Order No. 36 of 2003
