### WATER RESOURCES MANAGEMENT ACT NO.9 OF 2002

#### Declaration of the Matnakara Water Protection Zone (Tagabe River)

In exercise of the powers conferred on me by subsection 26(1) of the Water Resources Management Act No. 9 of 2002, I, Christopher Ioan, Director of Geology, Mines and Water Resources Department make the following declaration

#### 1 Declaration of Matnakara Water Protection Zone

- (1) The areas marked on the map that is attached to this instrument are declared as the Matnakara Water Protection Zone.
- (2) The Matnakara Water Protection Zone is divided into Zone 1, Zone 2 and Zone 3.

#### 2 Purpose for the declared Zone

The purpose for which the Matnakara Water Protection Zone is declared is:


- (a) to protect the quality and quantity of the Tagabe river as the only current water source for Port Vila, and the nearby settlements; and
- (b) to create a sustainable multi-purpose land use management water catchment model to be replicated in other watersheds in Vanuatu.

#### 3 Commencement

This notice of removal comes into force on the day on which it is made.




### CONSTITUTION OF THE REPUBLIC OF VANUATU
