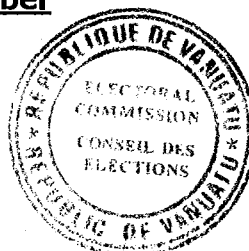
The closing of Proxy Application is on: Thursday 27<sup>th</sup> October 2005 at 4.30pm.
