The following persons are appointed as members to the Board of Arbitration.

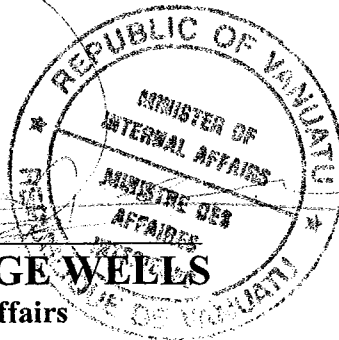
- (a) Thomas Banga as a representative of the employees; and
