### LIQUOR LICENCING ACT [CAP. 52]

#### Liquor Licensing (Prohibition of Sale) Order No. 33 of 2007

To provide for a prohibition on the sale of liquor in Luganville and Sanma Province.

In exercise of the power conferred on me by section 19 of the Liquor Licensing Act [CAP. 52], I, the Honourable JOE NATUMAN Minister of Internal Affairs, make the following Order:

#### **1 Sale of Liquor prohibited**

The sale of liquor in or from licensed premises throughout Luganville and Sanma Province whether for consumption on or off such premises, is prohibited from 12 Midnight on Tuesday 25<sup>th</sup> of September 2007 to 12 Midday on Thursday 27<sup>th</sup> September 2007.

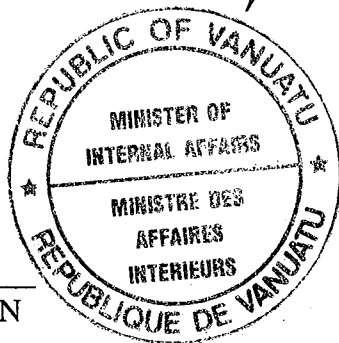
#### **2 Exception**

Liquor may be sold during the period referred to in section 1 within the normal hours of opening in restaurants and hotels to bona fide customers for consumption with food.

#### **3 Commencement**

This Order comes into force on the day on which it is made.
