The Schedule to the Official Salaries Act [CAP 168] is amended as set out in the Schedule to this Order.

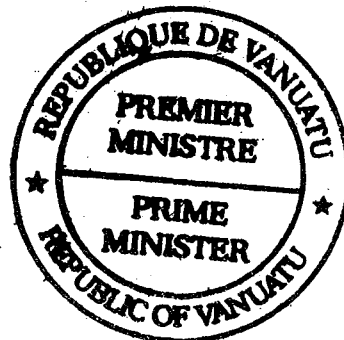
**2 Commencement**

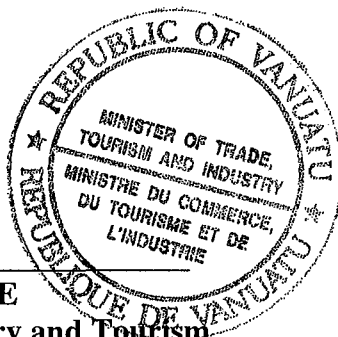
#### INSTRUMENT OF APPOINTMENT – CHAIRPERSON VANUATU TOURISM OFFICE
