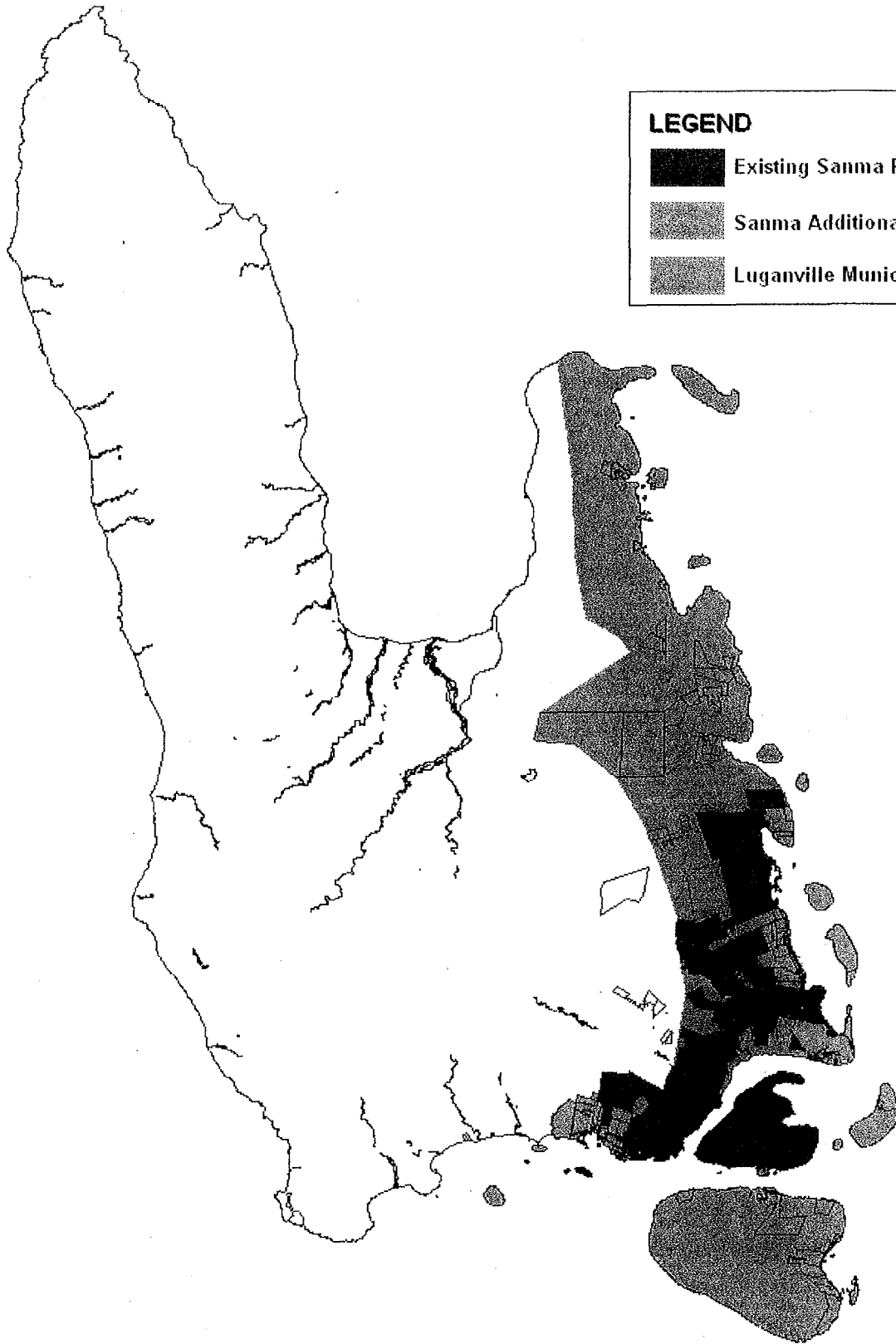

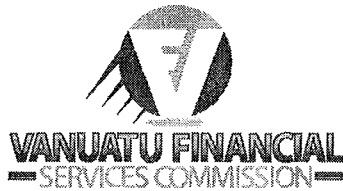
SANMA PHYSICAL PLANNING AREA






