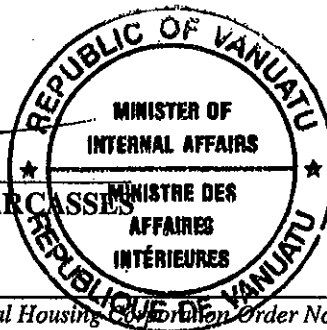



Office of the Chief Trade Adviser (OCTA) for the Forum Island Countries Order No. 11 of 2010

In exercise of the powers conferred on me by sections 5 and 11 of the Diplomatic Privileges and Immunities Act [CAP 143], I, the Honourable JOE NATUMAN, Minister of Foreign Affairs, make the following Order.

1 Interpretation

In this order:

Act means the Diplomatic Privileges and Immunities Act [CAP 143];

Office of the Chief Trade Adviser (OCTA) means the Office of the Chief Trade Advisor for the Forum Island Countries as established under the Agreement establishing the Office of the Chief Trade Advisor for the Forum Island Countries.

2 Office of the Chief Trade Advisor

The Office of the Chief Trade Advisor has the privileges and immunities set out in Schedule 2 of the Act and the legal capacities of a body corporate.

3 Officials of the Office of the Chief Trade Advisor

An officer of the OCTA (other than an officer representing the Government of Vanuatu in the OCTA) has the privileges and immunities set out in Schedules 3 and 4 of the Act.

4 Privileges and Immunities for the staff of the Office of the Chief Trade Advisor and the members of their family

A staff of the OCTA (other than a staff representing the Government of Vanuatu in the OCTA) and the members of his or her family forming part of his or her household are entitled to the privileges and immunities set out in Schedule 5 of the Act.

5 Commencement

This Order commences on the day on which it is made.



Any person having affected by the proposed declaration of the Council shall make representations to the Council within thirty [30] days from the date of publication of this Notice in the gazette.


