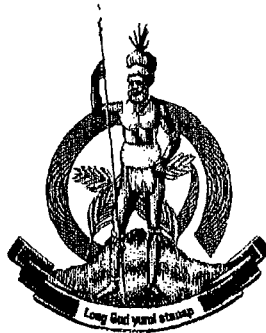

Official Salaries (Amendment) Order No. 21 of 2011

In exercise of the powers conferred on me by section 3 of the Official Salaries Act [CAP 168], I, the Honourable MELTEK SATO KILMAN LIVTUVANU, Prime Minister, with the prior approval of the Council of Ministers, make the following Order.

1 Amendments

The Official Salaries Act [CAP 168] is amended as set out in the Schedule to this Order.

2 Commencement

- (1) Subject to subclauses (2) and (3), this Order comes into force on the day of its publication in the Gazette.
- (2) Item 2 of the Schedule is taken to have commenced on 13 August 2003.
- (3) Item 3 (a) of the Schedule is taken to have commenced on 1 January 2010.

- (b) Add at the end in Column 3 "D+E+G+I+N+O(iii)+Q+W(1)+W(3)+W(4)" corresponding to "Assistant Private Secretary to the Deputy Prime Minister"
