#### Labour (Work Permits) (Exemption) Order No. 3 Of 2013

In exercise of the powers conferred on me by subparagraph 1(2)(e) of the Labour (Work Permits) Act [CAP 187], I, the Honourable TOARA DANIEL, Minister of Internal Affairs, make the following Order.

**1 Class of persons to be exempted**

Foreign investors who are certified genuine participants of the PR Program in Hong Kong are exempted from the requirements of the labour work permits.

**2 Commencement**

This Order is taken to have commenced on 13 September 2011.

### LABOUR (WORK PERMITS) ACT [CAP 187]

#### Labour (Work Permits) (Exemption) Order No. 4 Of 2013

In exercise of the powers conferred on me by subparagraph 1(2)(e) and section 14 of the Labour (Work Permits) Act [CAP 187], I, the Honourable TOARA DANIEL, Minister of Internal Affairs, make the following Order.

#### 1 Repeal

The Labour (Work Permits) (Exemption) Order No. 3 of 2013 made on 10 January 2013 is repealed.

#### 2 Class of persons to be exempted

Foreign investors who are holders of the Permanent Residence Visa granted under subsection 12(6) of the Immigration Visa Regulation Order No. 180 of 2011 are exempted from the requirements of the labour work permits.

#### 3 Commencement

This Order is taken to have commenced on 13 September 2011.
