AN ACT to authorise the issue and application of certain sums of money out of the Treasury Fund, the Western Samoa Treasury Banana Scheme Account, and the Samoan Public Trustee's Account, to the services of the year ending with the 31st day of December 1976 (hereinafter referred to as the year 1976) and to appropriate those sums of money to those services.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:—

1. Short title—This Act may be cited as the Appropriation Act 1975.

2. Grant and appropriation of \$15,384,228 out of the Treasury Fund—(1) There may be issued out of the Treasury Fund and applied to the services of the year 1976 any sums which do not exceed in the aggregate the sum of fifteen million three hundred and eighty-four thousand two hundred and twenty-eight tala.

(2) The sums authorised to be applied by subsection (1) of this section are hereby appropriated to the services expressed in the several votes specified in the Schedule to this Act.

3. Grant and appropriation of \$724,050 out of the Western Samoa Treasury Banana Scheme Account—(1) There may be issued out of the Western Samoa Treasury Banana Scheme Account in the Bank of Western Samoa and applied to the services of the year 1976 any sum which does not exceed the sum of seven hundred and twenty-four thousand and fifty tala.

(2) The sum authorised to be applied by subsection (1) of this section is hereby appropriated to the services of the Produce Marketing Division of the Department of Agriculture, Forests, and Fisheries.

4. Grant and appropriation of \$27,976 out of the Samoan Public Trustee's Account—(1) There may be issued out of the Samoan Public Trustee's Account in the Bank of Western Samoa and applied to the services of the year 1976 any sum which does not exceed the sum of twenty-seven thousand nine hundred and seventy-six tala.

(2) The sum authorised to be applied by subsection (1) of this section is hereby appropriated to the services of the Samoan Public Trust Office.
