## 1991 No. 4

**AN ACT to authorise the issue and application of certain sums of money out of the Treasury Fund, and the Public Trustee's Account to the services of the financial year ending with the 30th day of June 1992.** [29 June 1991]

**BE IT ENACTED** by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

**1. Short title and Application**—(1) This Act may be cited as the Appropriation Act (No. 2) 1991.

(2) Sections 2 and 3 and the Schedule of this Act relate to the service of the year ending with the 30th day of June 1992 (herein referred to as the year 1992)

**2. Grant and Appropriation of \$142,459,403 out of the Treasury Fund**—(1) There may be issued out of the Treasury Fund and applied to the services of the year 1992 sums which do not exceed in the aggregate the sum of one hundred and forty two million four hundred and fifty nine thousand four hundred and three tala (\$142,459,403).

(2) The sums authorised to be applied by subsection (1) of this section are hereby appropriated to the services expressed in the several note specified in the Schedule.

**3. Grant and Appropriation of \$638,745 out of the Public Trustee's Account—(1)** There may be issued out of the Public Trustee's Account in the Bank of Western Samoa and applied to salaries and other outgoings, charges and expenses lawfully incurred or payable in administering the Public Trust Office for the year 1992 sums which do not exceed in the aggregate the sum of six hundred and thirty eight thousand seven hundred and forty five tala (\$638,745).

(2) The sums authorised to be applied by subsection (1) of this section are hereby appropriated to the services of the Public Trust Office.
