AN ORDINANCE

made by the Administrator of the Territory of Western Samoa with the advice and consent of the Legislative Council of that Territory, and in pursuance of the Samoa Act, 1921.

1. This Ordinance may be cited as the "Ordinances and Law Revision Ordinance, 1931."
2. The Ordinances and Proclamations set out in the schedule hereto shall be deemed to be repealed to the extent specified in the said schedule as from such dates respectively as the Administrator may fix from time to time by Proclamation published in the Gazette. Repeal
3. All offences which have been committed previously to and all matters and proceedings commenced under any of the said Proclamations or Ordinances and which are pending or in progress on the date of the repeal thereof may be prosecuted continued or completed as the case may be in the same manner as if the said Ordinances had remained in force. Savings
4. The sixth schedule to the Revenue Ordinance 1929 is hereby amended by adding thereto the following charge "For every clearance issued to or in respect of a ship Ten shillings." Amendment to Revenue Ordinance, 1929
