AN ACT to authorise the issue and application of additional sums of money out of the Treasury Fund to certain services of the year ending with the 30th day of June 1994 and to provide for the reduction of certain sums of money previously appropriated for certain services of that year.

**BE IT ENACTED** by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short Title - This Act may be cited as the Supplementary Appropriation Act (No.2)

2. **Application** - Sections 3 and 4 and the Schedule of this Act relate to the year ending the 30th day of June 1994 (herein referred to as "the year 1993/94").

3. **Amendment to Appropriation Act** - The Appropriation Act 1993/94 is amended reducing the appropriations authorised pursuant to that Act by the sum of \$65,000 by effecting the reduction shown in column 2 of the Second part of the Schedule of this Act.

4. **Grant and appropriation of \$2,409,844 out of the Treasury Fund** - (1) There may be issued out of the Treasury Fund and applied to the services of the year 1993/94 under the Appropriation Act, as amended by section 3 of this Act the additional sum of \$2,409,844.

(2) The sum authorised to be applied by Subsection (1) of this section is hereby appropriated to the services expressed in the votes specified in the first part and in column 3 of the second part of the Schedule to this Act.
